ORDER

The Additional Principal Chief Conservator of Forests (Special Afforestation) & Nodal Officer as per the letter read as 1st paper above requested Government of India to grant approval for transfer of lease hold rights of 4.93 ha of forest land from Karikkayam Small Hydro Electric Project to Ayyappa Hydro Electric Project and renewal of lease condoning delay in submitting the proposal. As per the letter read as second above Government of India conveyed Forest conservation clearance in favour of M/s. Ayyappa Hydro Electric Project and also granted in principle (Stage-I) approval for renewal of lease for a period 10 years from 28-12-2006 to 27-12-2016 in favour of M/s. Ayyappa Hydro Electric Project keeping in view of the progress of the project and the need for producing renewal energy in the larger public interest subject to certain conditions. The compliance report was communicated to Government of India as per the letter read as 3rd paper above and Government of India conveyed approval (Stage – II) as per the letter read as 4th paper above.

2. On the basis of the Government of India's approval, State Government are pleased to accord sanction, under Section '2' of Forest (Conservation) Act 1980 for renewal

of lease of 4.93 ha of forest land diverted for Karikkayam Small Hydro Electric Project for a period of 10 years from 28-12-2006 to 27-12-2016 in favour of M/s. Ayyappa Hydro Electric Project subject to the following conditions:

1. The legal status of the forest land shall remain unchanged
2. The total forest area utilized for the project shall not exceed 4.93 ha.
3. Any other condition that the Additional Principal Chief Conservator of Forest (Central), Regional Office, Bangalore may impose from time to time for protection and improvement of flora and fauna in the forest area, and public convenience.
4. The catchment area Treatment Plan shall be implemented as per the plan approved by Forest Department.
5. The DGPs readings of the 4.93 ha of forest land diverted shall be communicated to Government of India within 30 days.
6. Transfer of lease shall not be done without the prior approval of Government of India.

3. The Additional Principal Chief Conservator of Forests (Special Afforestation) and Nodal Officer will ensure compliance of the above mentioned conditions by the User Agency.
