**SITE INSPECTION REPORT OF DEPUTY CONSERVATOR OF FOREST, JODHPUR FOR THE FOREST LAND TO BE DIVERTED UNDER FCA**

The Proposal has been received by this office for diversion (under FCA 1980) of 4.95 ha. Forest land for non forestry purpose. The subject envisages the use of forest land for Construction Of 400KV D/C Bhadla (PG) to Bhadla II (TWIN HTLS) Transmission Line.

The site inspection of the land involved in the proposal has been done on 11-09-2020 along with forest staff and Associate Manager, Power Corporation of India Limited, 400 KV D/C Sub Station Bhadla-2, 115, Nandpuri Colony, Nagaur Road, Phalodi, Jodhpur 342301.

On inspection of the site, it was found that the land required by the user agency is forest land measuring 9.9 ha. It is lying in the Range Phalodi (Phalodi, Bap & Shergarh) and legal status of the land is Protected forest forest Phalodi Range (Nure ki Burj, Kanasar, Mandali, Netawato ki dhani, Baree Seed & Canal strip protected forest)

The requirement of forest land as proposed by the user agency in part-I is unavoidable and is barest minimum required for the project. All possible alternate route has been explored and no other feasible route except this.

There is no any rare/endangered/ unique species of flora and fauna found in the area.

There is no any protected archaeological/heritage site/defense establishment or any other important monument is located in the area.

It has been found that the user agency has NOT violated the forest (Conservation) Act, 1980 provision till date and no work has been started without prior permission.

Since the project Construction of 400KV D/C Bhadla (PG) to Bhadla II (TWIN HTLS) Transmission Line is important for transmission of electricity From various solar parks nearby Bhadla hence in view of the importance of this TL, project is recommended for acceptance.
