Administrative Approval is hereby accorded for Const. of 55.0 mtr span prestressed box type bridge over Ujh Halli at Chigh Kiya (Approach road to bridge) at an estimated cost of Rs. 244.98 lacs (Rupees Two Crore Forty Four lacs & Ninety Eight Thousands) only as per detail and cost abstract to this Order as per Annexure-I

The Administrative approval is however, subject to the following conditions:-

1. The works shall be executed after observing all Codal formalities/ procedures.
2. It must be ensured that there shall be no multi-source of funding or overlapping of scheme under different programme.
3. The scheme shall be executed only after encumbrance's free land is available.
4. That the works are executed strictly as per provisions and specifications of the sanctioned estimates.
5. Schemes/ project shall be completed within stipulated time.
6. There is no time over-run or cost over-run involved in the project.
7. Accord of Administrative Approval shall not be treated as an authority to spend money not provided for in the budget. However the work shall be executed only to the extent funds released during the current financial year.
8. The work shall be executed in accordance with relevant standards set under MORTH/IRC/BIS/NBC Code of practice.
9. The detailed estimate of the work shall be technically sanctioned by the competent authority and proposals strictly devised and designed as per the relevant code of MORD/MORTH/IRC/BIS/NBC specifications.
10. Any such item (s) not covered under relevant schedule of rates is paid in accordance with the set codal procedure.
11. Rates provided as lowest market rates (LMR) shall not be construed as approved rates. Executive Engineer shall follow the codal procedure while making such payments.
12. The NOC from the concerned regulatory Authorities is obtained before the commencement of the work.

In reference to your office recommendation vide letter no. SEU/Drg./2021-22/8811-14 dated 26.11.2021, the Technical Sanction to the estimate of above referred work amounting to Rs 235.50 lacs (Rupees Two hundred thirty five lacs fifty thousand only) is hereby conveyed subject to following conditions:-

1. Work has been executed as per standard specification on which rate allotment has been made.
2. Rates allotted / provided in the estimate are certified to be the reasonable for such type of work by the Executive Engineer.
3. Technical sanction shall not be construed as any approval and proper rate analysis/tender rate/sanction Schedule of rate shall be followed to ensure reasonability/rationality of rates.

9. All quality control tests are conducted.
10. No change in proposals / specifications envisaged in the detailed estimate technically sanctioned shall be made without prior approval of competent authority.
11. Rates provided as lower market rates (LMR) shall not be construed as approved rates. Executive Engineer shall follow the codal procedure while such payments.
