1.Project Details:-

- I) Short narrative of the **Purpose:-** I Shri Suresh Rambhau Giramkar proposal and project / farmer of village Kurvati Tal-Velha District-scheme for which the Pune. Our Malki land Gut No.1 is near forest land is Panshet Dam of Taluka Velhe District-Pune. required.

As need and demand of water for drinking and farming activities we intends to lay out underground water pipelines from back water of Panshet Dam of Taluka Velhe District-Pune for drinking water & irrigation purpose. It is observed that the alignment of the proposed water pipeline is to be passing through the Forest Comptt.No.213 S.No.39 Gut No.3 lies exactly between the back water of Panshet Dam of Taluka Velhe District-Pune and our farmlands.

The forest area demanded is the barest minimum and immediate requirement for the proposed pipeline project and there is no

alternative non forest land available for this purpose.

Due to irrigation scheme the problem of drinking water will solved and the agricultural production will increase and the dairy farming will also help to increase the level of business of land holder in my family, which will speed up their annual income. Hence it would help to achieve the National Productivity also.

We have examined other possible alternatives for construction of laying underground pipeline. But it is not possible to avoid the forest land. It is unavoidable. The construction of pipeline from forest area of this purpose of water pipelines is only 0.009 ha.

Now we learn from the forest department that the construction of pipeline required land is Reserved Forest land. However, the prior permission of the Government of India, under the provision of the Forest (Conservation) Act, 1980 is necessary & essential for carrying any non-forestry work in such forest land. We are aware of the fact that such forest land comes under purview of the provisions of the

Forest (Conservation) Act 1980, making it incumbent on the State Government to obtain prior approval of the central Government under the provision of the said Act. Hence submitted this proposal for approval.

V) Justification for locating the project in forest area.. The other all possible alternatives were examined by us. It is not possible to implement the proposed project without avoiding the forest areas of Forest S.No. 39 G.No.3 of Village Kurvati Taluka Velhe Dist Pune.


