1	In reference to the observation-1.	This road falls under the MLA Priority for the year 2019-20 and the approved copy of administrative approval has been uploaded and the approved copy of DPR will be uploaded after the in-principle sanction and before the final approval of the FCA case as uploaded by the by user agency at Part-1 and attached at Sr. No. 42 i.e Undertaking regarding DPR.
2	In reference to the observation-2.	The alignment from non-forest land has not been found feasible due to a much steeper gradient which will consequently cause hindrance to the movement of heavier vehicular traffic on the road in the future. The private land shown in the alternative cannot be used as the locals have refrained from giving the gift deeds and thus the land acquisition is not possible case attached at serial No. 44 in additional information i.e Detail of observation attended.
3	In reference to the observation-3.	The dumping sites initially proposed has now been changed and the same have been shown in the KML file. Attached at Form A Part-1 (C) i.e. map of forest land to be proposed.
4	In reference to the observation-7.	As desired by the MoEF to proposed the new CA site with vegetation density less than 40% selected. Accordingly the new CA site RF Sataun C3 area 3.84 hac, is proposed for CA the KML file, Digital Map and Topo Sheet of the CA case is uploaded on the parivesh portal. As per CH file the density is 2-04.
5	The proposed site is located in slopy/hilly terrain and involves felling of large number of trees (200 trees) which may cause accelerated soil erosion/land slide. Therefore, state Govt. may provide details of the mitigation measures to be adopted to arrest the aerated soil erosion/land slide during/after execution of project. Additionally, the state Govt.
