- 2. The proposal received has been found incomplete. The following shortcoming has been noticed in the proposal which is to be completed. Proposal folders received are returned herewith. All the requisite documents may please be placed in the proposal folder with proper numbering and index.
- 1. Estimated cost of the proposed project mentioned against column No.A-1(vii) does not seem correct and is likely to be reviewed and corrected. As for 17.260 Kms road, the estimated cost 6.5 lac has been mentioned.
- The KML file of the proposed road has showing the villages to be benefitted and 2. dumping sites has been marked on Google earth but as per latest GoI instructions in the earlier submitted proposals, the villages to be benefitted from the proposed road, dumping sites and alternate alignments are also required to be marked on KML file.

The separate enumeration lists of the trees coming in the dumping sites of the 3. proposed road are also required to be given and placed in the proposal folder.

- . The scientific names of all the trees have not been mentioned against column 4. No.4(ii) in online part-II. In online part-II, for some of the trees involved 'Others' has been mentioned. If the scientific name of all the trees involved is not appearing in the module, the scientific names of all the trees should be mentioned within brackets
- against the column of local name of the trees.

 Against column No.8(iji) q Whether the forest land proposed for diversion is 5. located within eco-sensitive zone(ESZ) of the Protected Area notified under Wildlife(Protection) Act, 1972 (Note: In case, ESZ of a Protected Area is not notified, then, 10kms distance from boundary of the Protected Area should be treated as ESZ): Yes has been mentioned whereas the Distance from Shikaridevi Wildlife Sanctuary and Eco sensitive zones has been shown as 2.5 km. It is clear that the proposed forest land is out side the boundary of protected area. Hence, 'No', is required to be mentioned against this column.
- Penal NPV has not been found placed in the proposal folder. 6.
- CA scheme has although been placed in the proposal folder and uploaded in 7. online part-II which is not on current wage rates. Further, CA has been proposed over 20.7148 ha of forest land but the area to be afforested(in ha) including maintenance cost upto 10 years 10.3574 ha instead of 20.7148ha.

Density of vegetation of proposed CA area is required to be specified in CA site 8. suitability certificate. There is difference in district profile mentioned in online part-II and hard copy of 9. part-II. Necessary corrections required to be made. No date has been mentioned for signing the hard copy of part-I. 10. All the photocopies placed in the proposal folder are required to be attested. 11.

There is difference in estimated cost of the proposed road mentioned in online part-I and in hard copy of part-I. Against column No. A-1(vii) of online part-I, 25 'lac has been mentioned and against golumn No.1(iii) in hard copy of part-1, only Rs.24.83lac has been mentioned. The estimated cost mentioned in online part-1

and mentioned in hard copy of part-I should match.

There is difference in employment likely to be generated, mentioned against column No.E in online part-I and given in hard copy of the proposal. Against column No. E(ii), '10' and against E(iii), '75000', has been mentioned whereas in '75000' mandays' has been hard copy of part-I against column No.1(vi), only mentioned. The employment details given in online part-I and mentioned in hard copy should match. Necessary corrections are required to be made in the employment details.

No tree felling is involved over the forest land proposed for diversion whereas the 3. density o vegetation 0.5 has been mentioned against column No.4(1) an bill of NPV has also been calculated for dense forest. Necessary clarification is required to

be uploaded in this regard against additional information detail.

Working plan prescription has not been mentioned against column No.5 of

online part-II.

CA has been proposed over 1.52ha of forest land but the detail of patch has not been filled. The detail of patch is required to be filled. If the CA is to be proposed in terms of number of plants only then the detail of patch is not required to be filled.

The digital map of CA site is not as per requirement of GoI. Only on the image of 6. Google earth the coordinate have been shown. It is required to be shown on

toposheet of the proposed area.

Density of veretation of proposed CA area is required to be specified in CA site

suitability certificate.

Against additional information detail of online part-II. 9 documents have been 8. uploaded but the detail of uploaded documents has not been given against column. The detail of each uploaded document is required to be given against remarks column.

In district profile the detail of only 2 approved cases have been shown since 1980. In this regard it is required to be clarified by the DFO concerned that since 1980, only two proposals have been approved in his division. No dates have been mentioned in part-I and part-II of the proposal folder. 10. In online the recommendations of CF concerned (part-III) has not been 11. recommended by CF concerned. Revenue papers of the proposed diversion have not been placed in the proposal 12. 13. All the documents placed in the proposal folder either should either be original or attested one.
