1	In the Part-II Sr. No. 8, Statement showing detail of non forest area involved in the proposal is 0.0003 but in the part-I, the area of non forest land is mentioned as 0. kindly clarify the same.	The non-forest area in the proposal is only 7 meters which is only 0.0003 in hectare. Due to the non-forest area being very small, it automatically appears as 0 when it is shown in part-1. So that the area of part-I uploaded by Gujarat Gas does not match with the Part-II. Therefore, we request you to compare the non forest area in Part-II with the area statement which is submitted with proposal so that the both areas will match.

Hope you will find our submission in order. We request you to kindly take up the matter on priority and do the needful for granting permission at the earliest.
