Brief Note Regarding Ownership Issue In Village Kathali

1. As per revenue record (Mistal Hakiyat) year 1906-1909, the ownership of the land with respect to village Kathali was recorded in private ownership which continued till the year 1956.

2. Thereafter, the ownership of the land was vested in favour of State of Punjab and state of PEPSU which was classified as Class-II Forest as per the erstwhile Patiala Forest Act, Demarcated Forest D-48 Raikot now D-227 Raikot vide mutation dated 11.12.1957 on the basis of notification no. 40 dated 04.01.1953 issued by Secretary to the Govt. of PEPSU.

3. As per Jamabandi for the year 1972-73, the state government was recorded as owner and Makbuja Forest Department & tenant were also recorded in possession of land.

4. In the year 1977 under the provision of Himachal Pradesh Tenancy and Land Reforms Act, 1972, the tenants become the owner of the land in question. The same in prevailing as per revenue records till date.

Four laning work from Solan-Kaithlighat section of NH-05 were taken up by NHAI

1. Accordingly, during 2013 NHAI started the acquisition process for widening of road from Solan-Kaithlighat section of NH-05. 3A & 3D of village Kathali were notified vide Gazette Notification dated 27.02.2013 & 11.09.2013.

2. However, DFO, Shimla vide letter no. 938-39 dated 08.05.2013 submitted that status of few khasra nos in village Kathali as Forest Land and also asked DC, Solan to issue the direction to the concerned official to get the revenue records verified/corrected.

3. In respect of the issue regarding land in village Kathali, various meetings were conducted under the Chairmanship of Chief Secretary, Govt. of HP on 21.10.2019 & 05.02.2020. Further a meeting was also held with CM, Himachal Pradesh on 17.01.2020 regarding the same issue.

4. Meeting with DC, Solan was also held on 10.02.2020 in respect of Kathali Forest issue wherein DC, Solan asked NHAI to submit an undertaking regarding payment of

compensation to the rightful owners & asked Forest Department to file a civil suit for seeking correction of revenue entries.

5. Accordingly this office submitted an undertaking vide letter no. 3722 dated 27.02.2020 & Addl. Chief Secretary through CF, Shimla filled the civil suit in civil judge (junior Division) Kandaghat on 20.03.2020 for permanent prohibitory injunction on title issue.

6. Since the matter was sub judice before Civil Judge (Junior Divisiob) Kandaghat, hence NHAI sought ncesssary direction from Hon'ble High Court vide CWP no. 5537 of 2020.

7. Hon'ble High Court via judgment dated 08.12.2020 (Copy Enclosed) has issued following directions:

- "The Forest Department concerned shall forthwith purvey to the petitioner, the entire records appertaining to the enumeration of trees hence existing on the afore stretch of forest land and thereafter the petitioner authority, shall forthwith or with utmost promptitude hence proceed, to, inasmuch, as, within one month from today, and strictly in accordance with law, complete the markings of apposite sanctions.
- Upon permission being received from the Regional Office, Ministry of Environment, Dehradun, both for felling of trees existing upon the forest land and also for, conversion of the forest land, to non forest land or for its use for construction of road(s) thereupon, the petitioner authority shall proceed to forthwith execute the road construction activity and shall completely, complete it within six months".

8. Accordingly enumeration of trees were started by Forest Department & 1155 nos of trees were enumerated (177 nos of trees & 978 saplings) by RO Taradevi & forwarded to DFO, Shimla on 10.02.2021.

9. After necessary codal formalities, NHAI uploaded the subjected FCA case on eparivesh portal on 30.04.2021.
