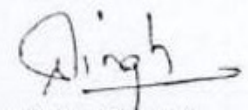
**Subject: Submission of Joint Inspection report of the land proposed for auction.**

\* In Seer Khad Khasra Nos. 100 and 76 in Moihal Jhareri are very large in area . So these khasra numbers are divided in two parts and named as Jhareri-I and Jhareri II those were examined by the committee during the course of joint inspection . Besides

this khasra nos 41 and 46 in Mohal Ree were also examined during the course of inspection. All these khasra numbers of Mohal Jhareri and Ree are situated in the middle of the seer khad. During the course of inspection it is found that there is no IPH scheme and any kind of road exists nearby this area. As the area proposed for auction is situated in the middle of the khad, hence there is no plants /trees are existed. The whole area is a Govt. Land and is found suitable for auction as there are sufficient minor minerals available in this area and replenished every year in rainy season.

Finely committee recommended the following khasra numbers of quarries proposed to put to auction for collection of minor minerals i.e. sand, stone and bajri and department of HPPWD, I&PH, Pollution Control Board and forest have no any objection.
