To whom it may concern

This is to certify that in respect of the proposed 400 KV D/C Nangalbibra –Bongaigaon Transmission line passes through few portions of Panchratna RF, Bagulamari PRF, Segunbahi RF, Rakhyasini PRF and Jangrajangsa RF under Goalpara Forest Division (T), Goalpara. There are no Tiger Reserve/ National Park/ Wildlife Sanctuary/Biosphere Reserve falling within the jurisdiction of Goalpara Forest Division (T), Goalpara. All the proposed area to be diverted for Construction 400 KV D/C Transmission line are free from any kind of protected areas as mentioned above.

But the nearest protected area i.e. Manas National Park which is under BTAD is at an aerial distance of 55 K.m to 58 K.m (approximately) from the proposed area to be diverted for Transmission line.
