I submit that in the reference 2nd cited, Government of India, Ministry of Environment Forests and Climate Change has enclosed a copy of the monitoring report for necessary action on non compliance of the conditions stipulated in the Government of India approval letter even No. Dt.21.07.2000 and other observation in the monitoring report in response to the diversion of 1.845 Ha of Forest land diverted in favour of Mahindra Industrial Park in Thirutheri RF of this division for the formation of access road from National Highways – Mahindra Industrial Park during the year 2000.

In the reference 1st cited it has been instructed to submit a full pledged report on the Government of India letter reference 2nd cited for non compliance of the conditions stipulated by Government of India while

I submit that in the monitoring report sent by Government of India, Ministry of Environment Forests and Climate Change the action on stipulated conditions under each part is described below.

PART I General Particulars

No observation has been made : NIL

PART II (Details of Compensatory Afforestation)

1. It has been observed that the non forest land handed over by Mahindra Industrial Park to the extent of 6.155 Ha in S.No218, 224, 225, 226, 229, 230, 338, 339, 227 and 244 has not yet been declared has Reserved Forests. In this regard I submit that necessary draft proposal for declaration of the area of 6.09.5 Ha of Non forest land for declaring the same under section 4 of the Tamil Nadu Forest Act 1882 was sent to Collector, Kancheepuram in this office Ref.No.4268/00 D Dt.23.04.2010 with a request to transmit the proposal to the Principal Chief Conservator of Forests through Conservator of Forests, Chennai circle for onward transmission to Government for declaring the area under section 4 of the Tamil Nadu Forest Act 1882. So far this proposal has not been transmitted to the Principal Chief Conservator of Forests.

- 2. In this connection I wish to point out that the District Collector, Kancheepuram inhis Ref.No.46719/10 B1 Dt.07.11.2011 has requested to Tahsildhar, Chengalpattu to submit his detailed report along with a recommendation through the Revenue Divisional Officer, Chengalpattu and the same is pending with the Tahsildhar, Chengalpattu till date. The District Collector, Kancheepuram frequently reminded by this office to obtain the proposal from the Tashildhar, Chengalpattu and Revenue Divisional Officer, Chengalpattu. The proposal is still with District Collector, Kancheepuram.
- 3. Compensatory Afforestation was raised over an area of 6.155 Ha at Appur Village during 2003-04 at an estimated cost of Rs.4.62 Lakhs and the survival of the plants planted during the year 2004-05 was 100%. In

the monitoring report it has been observed that the condition of plantation is 0% survival and no trees of at present.

In this connection it is submitted that the plantation raised in the CA land during 2003-04 has been failed due to the reason that the CA land has not been fenced and subsequent maintenance has not been taken up. Further adjacent to the CA land agricultural lands are located there by disturbance to the CA land by cattle mannace and hence 0% survival is noticed. Hence it is proposed to replant this CA land with misc plantations with proper fencing of the CA land in order to protect the area from cattle mannace for raising CA a sum of Rs.2.70 lakhs at Rs.44000/- per ha. In addition this area has to be fenced by providing chain link fencing for which a sum of Rs.30.00 lakhs will be required for fencing the peripheral of the CA land to a length of 1 KM at Rs.3000/- per RM. Hence a total amount of Rs.30.00 + Rs.2.70 = Rs.32.70 lakhs will be required. The user agency has already remitted a sum of Rs.28.96 lakhs.

The subject forest land diverted for approach road, however same has made been as concrete road with black topped and only small stretch of the road has made paver paver blocks. Electric line drawn in the diverted forest land. Some ornamental plants have been planted on either side of the road. Optical fibre cable (OFC) lines of different companies are drawn in the diverted forest land. Commercial advertisement boards are erected all along the road sides and on

road divider. A11 these activities have been carried out without obtaining of prior approval of Government of India and same attracts violation of Forest Conservation Act 1980.

The diverted forest land was laid with concrete road with black topped and MIP was instructed the PCCF by Ref.No.65114/03 /TS3 Dt.01.12.2015 that black topping of road is objectionable under Environmental protection Act and Forest Conservation Act 1980 and it was requested to them to lay pre -cast cement concrete labs for the balance length of 100 Mtrs and the manufacturing work of precast concrete slaps should not be taken up in the forest area. (Copy enclosed) In connection with laying of optical fiber cable of different company and electric line etc., the user agency was requested to explain the reasons for the violations noticed in this office Ref.No.3629/13 D Dt.16.03.16 and copy of the same is enclosed for kind perusal.
