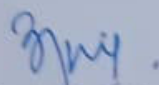
Sir,

In this regard, it is intimated that the Govt vide letter No. Ind-II(F)6-36/2017 dated 04.10.2024 has conveyed the approval for the extension of validity period of Letter of Intent for an additional term of one (01) year w.e.f. 24.05.2024 in your favour for obtaining environment clearance and completing other codal formalities, with the condition that this is the last extension of validity of the Letter of Intent. as requisite clearances have not been procured since 2018.

Accordingly, the period of Letter of Intent for auctioned quarry Jhareri-I, over an area measuring 08-16-83 hectares bearing Kh.No. 100 (Government land) falling in Mauza/Mohal Jhareri of Tehsil Jhandutta, Distt. The applicant shall not resort to any mining activities till getting the final grant order in this behalf.

LETTER OF INTENT

The Tender-cum-Auction of Minor Mineral Quarries of District Bilaspur was held on 29.01.2018 by the Auction Committee constituted under the Chairmanship of Additional District Magistrate, Bilaspur, District Bilaspur, H.P. During the auction of Jhareri-I quarry, the highest annual auction bid of Rs. 57,00,000/- (Rs. Fifty seven lakhs) only was offered by Sh. Shyam Kumar, S/o Sh. Sita Ram, Village Tikkari, P.O. Panjgain, Tehsil Sadar, District Bilaspur, H.P. On the basis of recommendation of the Auction Committee, the matter was referred to the Government for obtaining approval for issuance of Letter of Intent in favour of highest bidder. Accordingly, as per approval conveyed by the Government vide letter No. Ind.-II(F)6-36/2017 dated 31.03.2018, the Letter of Intent for extraction of Sand, Stone & Bajri from Jhareri-I quarry over an area measuring 08-16-83 Hectares bearing khasra number 100 (Government land) falling in Mauza & Mohal Jhareri of Tehsil Sadar, District Bilaspur, H.P. for a period of 15 years is hereby issued subject to the following conditions:-

1. The Party shall get the area demarcated from the revenue authorities and shall erect permanent boundary pillars to the satisfaction of the Mining Officer so as to clearly depict the area for which letter of Intent is issued. A copy of the demarcation report shall also be submitted to the Mining Officer concerned.
 2. The party shall have to submit the approved Mining Plan under Rule 35 of Himachal Pradesh Minor Minerals (Concession) and Minerals (Prevention of illegal Mining, Transportation and Storage) Rules, 2015.
 3. The party shall have to obtain Environment Clearance under the provision of Environment Protection Act, 1986 from the Competent Authority.
 4. The party shall pay the 25% amount of the offered bid amount as upfront premium (non-refundable) within one month from date of issue of this Letter of Intent, which shall be adjustable against first quarterly installment of the quarry.

5. The party shall have to obtain Forest Clearance under the forest Conservation Act, 1980 and amendments/notification issued time to time in this regard from the Competent Authority.
 6. The party shall have to comply all the notified terms and conditions of auction held on 29.01.2018.

The Letter of Intent is subject to any order passed by the Hon'ble Supreme Court of India/Hon'ble National Green Tribunal/Hon'ble High Court of Himachal Pradesh or other concerned Department from time to time in this regard. This letter of intent is valid only for obtaining requisite clearance from the Competent Authority.

The grant order imposing all the conditions and stipulations relevant as per rule shall be issued only after completion of the above conditions numbers 1 to 6 and after completing requisite codal formalities. This Letter of Intent shall be valid for period of one year. Thereafter, extension of period shall be granted only after reviewing of the progress made for fulfillment of the above said documents. The party shall not resort to any mining activities till the signing of contract agreement.
