With respect to the clarification sought in the above referred letter, we would like to clarify as under:

We have applied for diversion of 2.02ha forest land in F.Sy. No. 47 of Chipagi village in Sirsitaluk, for construction of hospital in 1998. Our proposal got approved after a very long period in 2016 and the handing over process took another two years. We got possession of the diverted forest land in 2018. Naturally, during the lapse of this long duration the requirements of our Society have changed with changing demand of our members.

So our management has decided to use a portion of the diverted forest land in F.Sy. No. 47 of Chipagi village in Sirsitaluk for carrying out some of the
