On completion of 50% work if the appraisal of the project shows that it will necessitate revision of estimate based upon the physical completion of the project vis-à-vis financial expenditure immediate steps should be taken to submit the revised estimate so as to ensure that the sanctioned revised estimate is available before necessary for incurring expenditure beyond permissible limits arises.

The technical approval and financial sanction may lapse after six months from the date of its issue in respect of work is not awarded within that period.
