

With reference to the above subject you have asked for identification of 35 ha of degraded forest area for plantation in lieu of the 16.246 ha forest land diverted under proposal No. regarding FP/KA/IRRIG/41736/2019 in your division as per ref (1).

So, The Range Forest Officer Chickballapura has identified 35 ha of degraded forest land in Yerramarenahalli village Sy No. 41 of Narasimhadevarabetta IVBlock, Chickballapura Taluk & Thekalahalli village Sy No. 22 of Narasimhadevarabetta IVth Block, Gowribidanur Taluk. The RFO has sent Form-C (Land Suitability Certificate), Topo Map, Geo reference map & KML file in ref (3).

The rates for Compensatory afforestation have been revised as per ref (4). These rates have been used for preparing CA scheme and calculation of the amount to be paid by the user agency. Details are as follows.
