Inole Village: Area 123.6027 Ha (Sy No 171):-

Inspected the proposed CA area in lieu of Forest area diverted for Palamuru Ranga Reddy Lift irrigation scheme. Inspected the Survey No 171

near Inole village along with Deputy Engineer, Asst., Engineer, Palamuru Rangareddy lift irrigation Scheme and preamble the entire area, the concerned user agency has demarcated the area and erected



pillars on interval of 100 Mts. During field inspection, the user agency has conducted DGS survey and prepared the map. It is observed that the area is



mainly hilly with gentle slopes having boulders available which is suitable for planting. The area is covered with tree growth and planting need not be done in the entire area. The area is just adjoining to Compt. No 63 of Amrabad R.F. of Inole

beat of Achampet Range. Species available in this area is Narlinga, Nemalinara, Billudu, Jana, Palakodisa, Neelamarri and other bushes. Planting and SMC works to be takenup duly adopting Mini Percolation Tanks, RFDs, CCT and Staggered trenches and it is also taken-up Trench bund planting. 123.6027 Ha out of that 80 Ha area is proposed for planting with inputs like imported soil and balance area ie 43.6027 Ha proposed for broad casting of seed from where ever necessary. Since area is adjoining to forest area, the CA area proposal is accepted.
