A. The CCF/Conservator of Forests, Karimnagar, Medak and Rangareddy Circles; the District Forest Officers, Jagitial, Sangareddy and Vikarabad districts are being informed that only DGPS data is verified, it is requested to verify the absolute locations of forest lands proposed for diversion with respect to Gazette notification, to add/delete the areas, if necessary.

- B. The User Agency is informed that for considering the application for use of Forest Land for non-forestry purposes, the User Agency needs to upload the proposal in the Ministry's website i.e., https://parivesh.nic.in./ besides submission of hardcopies i.e., (8) sets of proposal in Forest (Conservation) Act, 1980 addressed to this office along with all required information/ documents, including the authenticated maps. If the areas found to be falling in any protected area during the ground verifications, the User Agency is also required to submit (18) sets of proposals to this office in WL format for processing under Wildlife (Protection) Act,1972, and to upload the same at https://parivesh.nic.in.//, Step-by-step procedure is available at Ministry's portal. Further, the User Agency is requested to furnish photographs of instruments while observing over SoI GCP to ascertain whether instrument is placed properly or not over SoI GCP and to issue revised maps, if necessary. The application shall be forwarded after furnishing photographs and also (C) below.
- C. In addition to above, the User Agency is requested to pay an amount of Rs.13,500/- (Rupees thirteen thousand five hundred only) towards verification and authentication of ETS / DGPS/ GNSS data in the form of a demand draft drawn in favor of "Joint Secretary, CEFNARM".
