Hisar (Haryana)** is hereby issued as approved by the Departmental Committee vide Superintending Engineer Hisar Circle memo No. 2659 dt. 01.04.2019 subject to the following conditions:-

1. That the construction work should be taken in hand/ started after taking Nishan Dehi from the Revenue Deptt. and there should be no encroachment on the PWD land which is recorded in the Revenue Deptt.
2. If any encroachment found on PWD land after construction, construction will be removed with his own cost.
3. There should be no hindrance of any kind to traffic, due to installation of sign board etc;
4. No material will be dumped on PWD land during construction.
5. As per instruction issued by the department & IRC 12-2009,  $0.40+0.05 = 0.45$  lacs onetime fee has been deposited by the retail outlet owner being Other District Road (ODR) as lease charges for 15 years vide Demand Draft bearing No. 487182 & 487183 dt. 10.04.2019

6. The oil company/ Retail outlet owner will be bound to follow the instructions of PWD B&R Deptt. and IRC.2009.
7. There should be no encroachment on PWD land.


