- 1. The project was allotted to M/s Mohan Singh Thakur, 75/11, Tarana Hills, Mandir, Tehsil Sadar, Distt. Mandi-175001, in elevation range (Weir to Tail race i.e MTWL) 767m-757m for 1.00MW capacity on Suketi khad. Now the IPP has submitted the DPR of Suket SHEP for 1.00MW capacity within allotted elevations. The same may be processed keeping in view the optimum potential of the stream and ensure the riparian distance of 50 mtrs elevation wise or 250m horizontal distance is to be maintained between upstream and downstream projects
- 2. Further, as per amendments in Hydro Power Policy notified on dated 4.3.2014, Technical Concurrence(TC) is to be accorded within 45days from the date of receipt of the Detailed Project Report.

3. In case the DPR is not as per the CEA/CWC guidelines the same be returned to Himurja within a week's time positively.

4. In case, IPP fails to attend to the observations within in stipulated time period the DPR of the project be returned to HIMURJA, with specific recommendations for initiating further action at Himurja level.
