

		Meeting held on 21/01/2020 and after detailed

		In light of the above, it is humbly submitted that after the disagreement of CF, Chhindwara the matter was discussed by higher authorities of State Govt. as well as IRO, Bhopal, MOEF&CC and only after their agreement the proposal was recommended by REC.  It is also to submit here that the coal mining is a site-specific activity, the subject 14 Ha Forest land is required for extraction of coal only. As such, it may please be agreed to be diverted for non-forestry purpose. User Agency has already agreed (as per the condition of recommendation of State Government) to compensate for plantation done on subject 14 Ha forest land for maintaining Safety Zone/ Green Belt which is required to be done to protect adjoining Forest Area from already diverted area of 19.50 Ha which is being used for non-forestry activity.

2	The State Government informed that the instant diversion is an extension of Bharat Open Cast Phase-II Coal Mining and is part of original proposal of 68.704 ha and 19.50 ha for which approval was already granted by the Ministry in past. - 1,000		Therefore, the question of not maintaining Safety Zone around the approved forest area of 19.50 ha does not arise. Also user agency shall maintain the safety zone of proposed 14.0 Ha. Forest land.
		It may be further mentioned here that Rs. 59,85,347.00/- is already deposited by WCL Kanhan Area to Forest Dept. by EFT No. 140992 Dated 27/06/2013 for the purpose of Safety zone. Copy of the payment receipt is enclosed as Annexure-VI for ready reference.
6	The KML file of CA sites after excluding the areas unsuitable for plantation has not been uploaded on PARIVESH portal. The State Govt. may look into the matter and propose suitable areas for Compensatory Afforestation. The Site suitability certificate for the proposed CA sites is also required to be submitted.	State Forest Dep't. is requested to take necessary action in this regard.
