enumerated & found as 1236 in numbers in all three villages. Thus, total number of trees in the entire forest area of the Pachwara South Coal Block (PSCB) enumerated as 91,464 numbers, including 1236 no. of "Sal & its associates" tree having girth in between 20-30 cm. The abstract of total tree enumerations in the forest area of PSCB is attached for kind perusal. 4 site inspection carried The out on enumeration of trees 09.05.2022, it is found that marking has not done in conducted in the entire forest area of the few of the trees. Also Coppicing/regenerations is Pachwara South Coal Block (PSCB) observed in the proposed forest area under comprising as 455.1108 Ha in all three diversion while the total no. of tree in 0-30 cm girth project affected villages namely class is reported only as 1326 numbers. Chirudih, Kundapahari and Mahuldabar Clarifications on above to be provided. including the area of jungle jhari, waste land and Sec-4 notified forest. Total number of trees having girth more than 30 cm is enumerated as 90,228 in all three villages. However, marking on the trees could be completed for 82,616 trees only and remaining 7,612 numbers of trees were enumerated but could not be marked on ground due to resistance from the villagers. In the abstract of tree enumerations, the no. of trees under 0-30 cm girth represents the specific variety of trees only i.e. "Sal & its associates" tree. As there was extreme profuse regeneration, only "Sal & its associates" tree having girth in between 20-30 cm was enumerated & found as 1236 in numbers in all three villages. Enumeration of trees from 0-20 cm was not feasible due to profuse regeneration as observed during the site inspection carried out on 09.05.2022 as well.
