This is with reference to the Forest Diversion proposal, proposal no FP/JH/MIN/147316/2021. We hereby submit the following details regarding the subject matter.

Patratu Vidyut Utpadan Nigam Limited (PVUN Limited) A JV Company of NTPC Ltd and Jharkhand Bijli Vitran Nigam Limited (JBVNL) was incorporated on 15.10.2015 to install 4000 MW coal based thermal power plant consisting of 5 units of 800 MW each which is to be implemented in two phases (Phase I: 3 x 800 MW and Phase II: 2 x 800 MW).

Ministry of coal has transferred Banhardih coal block and assigned to PVUNL located in Auranga coal field in Latehar district of Jharkhand State vide order No 103/18/2015 NA on 25.06.2018 for captive use.

The Mining plan of Banhardih was approved by Ministry of coal on 15.07.2021 for an area of 1467.42 Ha with a target for commencement of Mining operation in FY 2024-25. Notification & publication of Section 11(1) under CBA A&D Act for the total projectized area for 1467.42 Ha has been issued by Ministry of Coal. Further, various developmental activities & approval of statutory clearances for the development & operation of Banhardih Coal Mining project are at advance stage at different level. In addition to above, Ground water clearance from CGWA and issuance of NOC for Nallah diversion & preparation of wildlife management & conservation plan is under finalization and shall be submitted for approval very soon. Further, we have also represented our Environmental Clearance proposal in the last three EAC meeting held on 09.06.2022, 15.12.2022 & 12.02.2024. In the last EAC meeting held on 12.02.2024, our Environmental Clearance proposal was apprised & Minutes of the meting released and preparation for submission of compliance is under progress.

It may be brought to your kind knowledge that we have submitted our FDP(Form-A) proposal in 18.09.2021, it was accepted by PCCF nodal **on 23.11.2021** and forwarded to Divisional Forest Office on **25.11.2021**. Further, our proposal was further accepted by DFO, Latehar on 13.01.2022. Subsequently, the EDS raised by DFO Office on **08.02.2022** which is before enactment of provisions and guidelines on Compensatory Afforestation issued on **Aug 2023**.

All the EDS compliances have already been completed & complied and now the proposal is ready for onward submission for further processing by processing authority.

Further, it is also imperative to mention here that the current diversion proposal is no-linear acquisition, and no activities shall be undertaken before the grant of FC Stage-II.

As per the compliance of EDS, the finalization and certification of degraded forest land of 1050 Ha has been completed which is twice in the extent of forest land proposed for diversion of 515.32 Ha (Notified Forest Land - 497.02 Ha & Deemed Forest -GMJJ land – 18.30 Ha).

As per the new provisions & guidelines on Compensatory Afforestation, user agency is required to provide land which is neither notified as forest under Forest Act 1927 or any other law nor managed as forest by the forest department which shall also bear the cost of raising Compensatory Afforestation over such land.

In this regard, it is humbly submitted that considering our FC Stage-I proposal is at very advance stage of processing by the processing authority, may be considered for further processing, examining and recommendation for onward submission with presently identified and certified degraded forest land earmarked for Compensatory Afforestation. Further, we shall also provide matching non forest land for Compensatory Afforestation and comply to the conditions of Compensatory Afforestation as per the provisions if the grant is not accorded.

In addition to above, action and process for identification of CA land (non-forest land) in parallel to processing of our proposal for further processing & examining would save time as the requirement and shall be complied before grant of FC Stage-II. As, we are already in delay in obtaining the FC Stage-I considering our proposal acceptance at PCCF Nodal on 23.11.2021 & EDS received from DFO, Latehar on 08.02.2022.

Furthermore, Banhardih Coal Mining project is a captive mine to Patratu Vidyut Utpadan Nigam Ltd (a Subsidiary of NTPC in JV with JBVNL, Govt of Jharkhand for supply of coal to Patratu power plant Stage I(800X3=2400MW) and the commercial operation date of the Plant (Unit -1) is scheduled in July'2024 and completion of total Phase-I 2400 MW plant by 2025. Out of the 2400 MW power generation, 85 % power is allocated for State Jharkhand and timely commissioning of Power Plant with sustainable fuel supply arrangement is essential for the growth of State. In this respect, coal production & supply from Banhardih coal mine is very much crucial for sustainability Patratu Power Plant and as per the conditions of Approved Mining Plan imposed by Ministry of Coal, the commencement of Mining activities is also scheduled in FY 2024-25.

It is also prudent to mention here that Ministry of Coal has apportioned INR154.5 Crore against slippage of milestone schedule as per the allotment agreement and subsequent delay shall cause further apportionment of Bank Guarantee against slippage of performance Milestone schedule.
