In this connection, the proposed roads of Panchayat Raj Engineering Department are Reserve Forest lands of Forest Department admeasuring Hec 4.63 and Hec 3.89 in Pedabayalu Mandal, Hec 4.24, Hec 3.67, Hec 1.72, Hec 1.90 and Hec 3.11 in G.K.Veedhi Mandal and Hec 3.30 and Hec 1.73 in Koyyuru Mandal and in lieu of the Forest land proposed for roads of Panchayat Raj Engineering Department, the Govt. Land measuring Hec.4.73 in Sy No 27 of Gurrai Village of G.Madugula Mandal and the Govt. Land to an extent of Hec 24.04 out of Hec.24.10 in Sy.No.147 of Arama Village of Dumbriguda Mandal proposed to be transferred on Compensatory Afforestation basis in terms of G.O.Ms.No 571 Revenue (Assignment) Department dt.14.09.2012.

In view of the above the Tahsildar, G.Madugula (for Hec.4.73 in Sy No 27 of Gurrai Village of G.Madugula Mandal) and Tahsildar, Dumbriguda (for Hec.24.04 out of Hec 24.10 in Arama Village in Dumbriguda Mandal) are directed to submit regular Afforestation proposals in full shape in the prescribed formats and check lists through the Sub Collector, Paderu duly following the guidelines issued in G.O.Ms.No 571 Revenue (Assignment) Department dt.14.9.2012 within 7 days urgently
