This is regarding the observation raised by Government of India, Ministry of Environment, Forests and Climate Change, New Delhi vide above referred letter, marked to end User Agency by DFO Office Bharmour on 10/05/2023. The clarification pertaining to User Agency is as furnished below:

Query: The state Govt. shall provide the complete layout plan indicating the components of the already diverted and the area now proposed to be diverted along with the corresponding KML file.

Reply: Following components are shown in the KML & layout drawings as required by referred letter cited above:

- i. Proposed 400 kV D/C Transmission Line from Tower no. 8 of Lahal-Rajera Line to Pothead Yard of Kutehr HEP (3.7904 Ha).
- ii. 220 kV old Transmission Line already diverted and transferred to HPPTCL (3.1715 Ha).
- iii. All the project component areas already approved and diverted for construction of Kutehr HEP (58.2368 Ha).

As desired, in the KML shows the Proposed 400 kV D/C Transmission Line in red colour, 220 kV old Transmission Line in green colour, the existing 400kV HPPTCL Lahal-Rajera line in blue colour, same KML is uploaded in Part-I additional information. Layout Plan, Geo-reference map, Digital Toposheet and break-up of the area of different components of the project are also uploaded in Part-I additional information and enclosed as annexure 1,2,3&4.
