

In connection with above subject and references for Forest land Diversion proposal (8.0357 Ha), the following remarks are furnished for observations raised vide above referred letter no. 03.

1. Hard copies of land plans duly certified by Revenue officials for Railway's owned land as a documentary evidence for possession of these forest patches at the time of construction of existing two Railway lines (During year 1919 & 1986) are being submitted for your office verification and due desired certificate.
2. The construction of new Railway line is to be done within the Railway's owned land and Forest Diversion is proposed for only some patches where the owned land is falling short. The MOU for utilizing the proposed forest patches by Railway only and not being shared with NHAI for construction work to restrict multiple sharing of diverted forest land has been procured vide this office letter dt. 03/04/2024 (Copy attached for ready reference).

3&4. For wildlife conservation plan and SBWL/NBWL clearance as per prescribed guidelines of FCA Railway has applied the proposal on Parivesh portal dt. 04/04/2024 vide Proposal no WL/MP/RAIL/468116/2024 and field inspection has also carried out on dt. 25/04/2024 for further action.

Sir,

In connection with Itarsi- Nagpur 3rd line project forest land diversion proposal is under way vide forest proposal no. FP/ MP/ RAIL/15007/2021 & FP/MP/RAIL/449339/2023.

Vide Regional Office Bhopal (MOEF & CC) letter no. 6-NPR027/2023-BHO dt. 17/07/23 and 6- MPR 027/2023-BHO Dt. 09/02/2024, no objection certificate and forest area which is under rediversion for use of NHAI and Railway was desired for further action (Copy attached).

In view of above following issues are being brought to your kind notice

1. There are following three locations at the Itarsi- Nagpur 3rd line project is crossing the NH69.

For above the scheme for crossing the Railway line by ROB is in process and yet not finalized for serial no 1 as above table. Vide your letter reference no 1, NOC has been granted.

2. In general the Railway do construct the part of structure which is over the existing and proposed track within the Railway ROW and approaches are constructed by Road Authorities with required land acquisition for approaches and diversions. In light of the same policy for above all three proposed ROB's Railway is acquiring required land for proposed structures over Railway tracks and at the same NHAI is suppose to acquire required land for proposed diversions and approaches. Hence both the organizations are to work in separate land and no issue is arising of bilateral use of diverted forest land. And in view of the above fact no question arises for rediversion for use of forest land by NHAI and Railway's. At the same you are requested for preparing the desired MOU in this regard please.

उपरोक्त विषयक सदमित पत्रों के संवध में अधोहस्ताक्षरी को यह सूचित करने का निर्देश हुआ है कि प्रस्ताव से संबंधित आर.ई.सी. बैठक दिनांक 29/01/2024 को आयोजित की गयी। बैठक में लिये गये निर्णय एवं कार्यवृत्त दिनांक 06/02/2024 (सदमित पत्र-2) एवं एफ.आर.सी.एम. बैठक दिनांक 06/02/2024 अनुसार अन्य वांछित जानकारी/स्वयं टीकरण की आवश्यकता है जो कि निम्नलिखित है:-

1. The State Govt. stated that the land occupied with existing line is in possession of Railways but no documentary evidence or certificate issued by the competent authority has been furnished showing the existing line constructed (in 1919 and 1986) on Railway owned land within Railway's right of way under Section 11 of Railways Act, 1989.
2. The area which is under re diversion for use of NHAI and Railway is also requiring to be mentioned.
3. With reference to this office EDS point 7 the comment of CWLW has been provided and was informed that provisions made in the document of WII regarding infrastructural Projects to mitigate measures for wildlife protection shall be taken under consideration during the work. Therefore, site specific activity/structure required and detail of fund provision for the same shall be provided to the REC.
4. This was informed by the concerned DFO that the area of the project falls in the Sarpura-Melaghat Tiger Corridor. As per prescribed guideline of FCA the proposal will require clearance from the NBWL in this case.




