Sub:- Diversion of 0.90 Ha of forest land in Ramavaram R.F in the erstwhile Kothagudem Division for installation of submersible pump sets, approach road, transmission line and water pipe line of Padmavathi Khani in favour of S.C.Co.Ltd., Kothagudem – Compliance report submitted – Reg.

With reference to the subject and reference cited above, the compliance report called for on condition wise for diversion of 0.90 Ha forest land in Ramavaram RF in the erstwhile Kothagudem Division for installation of submersible pump sets, approach road, transmission line and water pipe line of Padmavathi Khani in favour of S.C.Co.Ltd., Kothagudem are furnished below.

Condition No.	Condition	Status of Condition
1.	The Legal status of forest land shall remain unchanged.	
2(a)	The User Agency shall plant ten times more trees than likely to be felled.	Total (361) trees are affected for installation of submersible pump, road and water pipe line in area of 0.90 Ha. As per the condition No. 2 (a) of Govt. of India, the User Agency shall plant ten times more trees than likely to be felled. But 15050 No. of E.P clones were planted in Compt., No. 52 of Yellandu R.F., as per C.A Scheme proposals.
2(b)	User Agency shall raise and maintain the enrichment plantation in 9 Ha in adjoining forest area if density is lesser than 0.4 and protect it till life of the project.	The User Agency has paid an amount of Rs. 6.57 Lakhs towards cost of C.A Scheme (Ten times of trees likely to be felled) as per the demand of Forest Department. An area of 9.03 Ha Plantation was raised during the year 2011-12 in Compt., No. 52, Yellandu R.F of Yellandu Range and the subsequent maintenance works were taken up under C.A Scheme during 2012-13.
3.	The period of diversion under this approval shall be ten (10) years subject to possession of valid lease by the User Agency under the MM DR Act, 1957 so that it shall be Co-terminus.	The period of diversion will be 10 years, which is expiring by 17.08.2018.

4.	Any tree felling shall be done only when it is absolutely necessary and unavoidable.	Since the sanctioned forest land is for installation of submersible pumps, approach road, transmission lines etc., the trees were cleared by Forest Department and handed over to S.C.Co.Ltd., and accordingly the approach road and transmission lines were laid down.
5.	No damage to the flora and fauna of the area shall be caused.	S.C.Co.Ltd., has not caused any damage to flora and fauna. On the other hand, about 400 Ha of Plantation was raised in adjacent area within 5 KMs and hence, there is improvement in flora and fauna.
6.	It shall be ensured that no labour camps are set up inside the forest area.	No labour camps are set up inside the forest area.
7.	The mining lease area shall be demarcated on ground at the project cost, using four feet high RCC pillars with each pillar inscribed with the serial number, forward and backward bearings and distance between two adjacent pillars.	The area has been demarcated with RCC pillars of 4 feet height 22 Nos of pillars have been fixed.
8.	The forest land shall not be used for any purpose other than that specified in the proposal.	The forest land is not used for any other purpose in the proposal.
9.	Any other condition that the CCF(Central), Regional Office, Bangalore/ State Government may impose from time to time for protection and improvement of flora and fauna in the forest area, shall also be applicable.	No such condition was stipulated.
