




### ENQUIRY REPORT

As per the direction of Project Officer cum District Welfare Officer Kalimpong, vide Memo No 152/BCW/KPG Dated: 04/04/2022 a team comprising of officials from BL&LRO, BCW&TD and Gram Panchayat conducted a survey on 05/04/2022 regarding the viability and feasibility for laying OFC cable as part of Reliance Jio network from Jaldhaka to Kumani via Khunai More. During the enquiry, the enquiry officials were told by the representative from the Jio Company that the laying of cables would be being done on the right hand side of the road towards Jaldhaka from Khunia More and the proposed site of 3km does not come under any Forest village.
