महाशय,

उपर्युक्त विषयक प्रसंगाधीन पत्र के आलोक में कहना है कि चतरा जिला अंतर्गत 132 kV D/C चतरा से हंटरगंज तक संचरण लाइन निर्माण हेतु 53.2129 हे० (चतरा दक्षिणी 29.8774 हे०) वन भूमि अपयोजन हेतु समर्पित प्रस्ताव का सहायक वन महानिरीक्षक द्वारा उल्लेखित त्रुटियों का अनुपालन निम्नलिखित है :-

IV.	As per DSS analysis, it appears that proposed forest land for diversion has been violated by user Agency. If yes then it must be taken into Cognizance at the earliest and a complete action taken report against the perpetrators in this regard may be uploaded /submitted alongwith the explanation why the forest department could not assess the violation while processing the application.	Subjected line work has been awarded to agency M/s APSPL on 01.11.2018. After route alignment, agency informed that the out of 108 Locations, 49 Locations were laying in Dense Forest area whereas 59 locations were lying in Cultivating Land. Mistakes encountered by agency at locations those were on JJ Land Due to cultivated land, an inadvertent mistake encountered by agency i.e. out of 59 locations 29 locations (15 Nos towers under the jurisdiction of Forest Division Chatra North and 14 Nos towers under the jurisdiction of Forest Division Chatra South) foundation have been completed those are actually laying in forest /JJ land.

		Prima facie has seen that the mentioned 29 location which are seen as in cultivating land and the land owners have claimed of Possession and the same have been verified by the Public representative (Mukhiya). Accordingly the agency has done the construction work and disbursed the compensation through cheque to the respective beneficiary. Details can be seen as As Annexure -A. Hard copy of Cheques are also being enclosed for the reference
		Since this transmission line is an important project for transmission of electricity within state of Jharkhand to connect proposed 132 /33 Kv Hunterganj GSS and 132/33 kV Chatra(Darha GSS to facilitate power within chatra district and for the development of nearby area/blocks.
		Also during construction work at these locations no cutting / damaging of any tree neither any loss of animal husbandry was encountered. At present no any stringing of conductor has been done by agency in Forest/JJ land.
		Now the total affected area of forest/JJ land after Tower Foundation work under the forest Division (North) and Forest Division (South) are being Enclosed as Annexure-B
