You are also required to submit an undertaking that the information regarding qualification and experience of proposed key personnel and sub professional is correct and none of them have been black listed / debarred by the MORTH / State PWD. In case, it is found to the contrary at the later stage, action will be taken as per the contract condition.

Upon submission of required Performance Security you are required to sign the Contract Agreement with concerned Executive Engineer National Highway Division, and accordingly you are requested to mobilize the key personnel including Team Leader and other Field Staff and perform accordingly to the Contract provisions. Kindly acknowledge the receipt of same.
