Dear Sir,

I am pleased to inform that the above project has been considered by the Environmental Appraisal Committee in DST and is cleared from the environmental angle provided that the following safeguards are effectively implemented:-

1) Necessary arrangements may be made by the project authorities to provide fuel wood, free of charge, to the labour force during the construction stage of the project so that indiscriminate felling of trees in the neighbourhood may be prevented. Forest Deptt. may be requested to open fuel depots for this purpose and adequate provision to meet the cost of providing free firewood should be made in the project estimate.

2) During the construction operations digging of borrow pits should be avoided as far as possible and stress laid on the use of earth from mounds. Steps should also be taken to remove the scars of construction by levelling and land scapping etc., to prevent further soil erosion.

3) Necessary soil conservation measures should be taken during the construction of roads. Controlled blasting should be reported to and the services of a Geologist may be made available to the contractor to avoid unnecessary excessive blasting. The construction operations should be so phased as to provide sufficient time for road construction operations thereby eliminating the need for excessive blasting.

Any assistance in the implementation of the safeguards, if needed, shall be gladly extended by this office.

Dear Shri Oberoi,

Please refer to your D.O. letter No.NH/C D/73/6697 dated 26.11.85 regarding forest clearance and afforestation scheme of Uri Hydro Electric Project. I am please to inform you that this Department has no objection for the utilisation of 54.708 ha. of forest land for Uri Hydro Electric Project in J&K, subject to the following conditions:

1. Legal status of the land should be left unchanged.
2. Compensatory afforestation should be raised over an equivalent non-forest land at the cost of the project.
3. Free supply of fuelwood to the labour and staff engaged in the project work should be ensured or the cost of fuelwood should be defrayed against their salary/wages.
4. Vacant space available in the project area should be planted up with the suitable species.
