Moreover, it is seen form the map that the alternative alignment is running all along the proposed alignment which appears to be a mere formality done by the user agency. The state Government may submit the comparison chart of alternative explored and a detailed clarification of rejecting alternative.	Justification for rejection the alternative alignment has been corrected and uploaded at additional information details at part-I in form A. It has also been rectified in KML also and uploaded online.
7	In para-I of the FRA certificate issued by the District Collertor, Rudraprayag, it is mentioned that the 4.412 ha. Forest land propsed for diversion falls within the jurisdiction of Gophin village in Ukhimath Tehsil but the VLC proceedings of Chingwar village have been submitted with the proposal. State Government may submit clarification in this regard.	FRA certificate has been corrected and uploaded at point at K (i)(a) of part-I,form A. As the details filled in the certificate was wrong due to typing error. The case proposed for village chingwar only and proceedings of the same village is uploaded.
8	The hard copy of the SDLC meeting provided in the hard copy of the proposal has not been signed by the SDM and the date has also not been mentioned. State Government may submit the signed copy of the SDLC meeting proceedings with date in original.	Hard copy of FRA certificate with complete SDLC certificate in original has been submitted to Nodal office and the same has been uploaded at point K(i)(a) of form A.
9	It is seen from CA scheme that the total cost come out to Rs. 18,48,701.78 but at the end of the CA estimate, the cost has been mentioned as Rs. 24,60,611.95 quoting the reference of PCCF order No. 596/3-5-2 dated 19.08.2015 which is creating confusion. State Govvernment may remove this discrepancy and submit clarification in this regard.	The cost of CA has been calculated as per PCCF's order dt 21-11-2017 because state government has revised the rates per hectare but the rates of individual activity has not been revised yet. As soon as the revised rates of individual activity come, new CA scheme will be uploaded in part-II and paid accordingly.Presently the cost of CA is Rs 2977335.0 only.
10	The tree species like kachnar, Amla, Sahtoot and Bhimal are proposed to be planted in CA stipulated and progress of CA has been mentioned as 691.907 ha, 1158.614 ha, and 1158.614 ha, respectively which does not appear to the correct. State Government may provide the correct data of district profile at para 14, Part II online.	Related to DFO Rudraprayag.
