**Subject: Certificate for settlement of Rights under Schedule Tribe & Other traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 for Tilaboni UG Mine**

Dear Sir,

As referenced in the letter enclosed herewith, Tilaboni UG mine of Eastern Coalfields Ltd. is one of the ambitious mine of ECL with a production capacity of 1.86 MTPA. Out of total area of 869.00 Ha earmarked for the project, 41.53 ha is forest land (39.98 ha in Mine-I and 1.55 ha in Mine-II). Mouza-wise distribution of Forest land is given in **Annexure-I**.

Diversion of forest land (Mine-I) under FC Act, 1980 is necessary for utilization of Forest land for the purpose of mining. We have applied for said diversion in Form-A Part-I in Online Single Window (PARIVESH) Portal of MOEF&CC, GoI vide *Proposal No. FP/WB/MIN/41301/2019 dated 29.07.2019*.

As a prerequisite to this application it is required to provide documentary evidence in support of settlement of rights under the *Schedule Tribe & Other traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006*.

In view of the same it is requested to make necessary arrangement to organise a *Gram Sabha* at a suitable date for providing us with the certificate, as desired, under the said act in a prescribed format as per MOEF&CC circular No. 11-9/98-FC(pt.) dated 5th July, 2013 ( Enclosed as **Annexure-II**).
