In compliance to the Ministry of Environment and Forest (MoEF), Government of India letter No. 11-9/98-Fc (pt) dated 3rd August 2009, wherein, the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Traditional Forest Dwellers (Recognition of Forest Right) Act. 2006 ('FRA' for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated 5th February 2013, wherein MoEF issued certain relaxation in respect of linear projects. It is certified that 1.2 hectares of Forest Land proposed to be diverted in favour of National Highways & Infrastructure Development Corporation Limited (NHIDCL) for **Construction of Bi-Directional Tunnel at Km. 83rd (kuligarh) of length 495m including approach road of 664m and a major bridge of 110m from Km. 82+675+ to 82+925 on Batote -Kishtwar -Sinthanpass road section of NH-244** in Kishtwar District falls within jurisdiction of Village Chamoti, Tehsil Drabshalla

It is further certified that:

- (a) the complete process for identification and settlement of rights under the FRA has been carried on the entire 1.2 hectares of forest area proposed for diversion by Tehsildar concerned as reported vide No:733/OQ/TD Dated:20-03-2020. A copy of Resolution of Gram Sabha members and Report/Certificate of Tehsildar is enclosed as annexure 1 and annexure 2 respectively.
- (b) The diversion of forest land for facilities managed by the Government as required under section 3(2) of the FRA have been completed and the Gram Shaba has given their consent to it.
- (c) The proposal does not involve recognised rights of Primitive Tribal Groups and Pre-Agricultural Communities.
