The attention of the Forest Divisional Officer, Nizamabad is invited to the references cited and he is informed that in response to the instructions issued to the M/s Reliance Jio Infocomm Limited i.e., User Agency vide reference 3<sup>rd</sup> cited, the User Agency has submitted **revised ETS & DGPS raw data**, for the proposed alignment and requested for verification and authentication.

On verification of data, it is noticed that the data given by the User Agency is 3.6 mts away from SOI (GCP). As there is deviation of 3.6 mts of coordinate's base, though the base station is kept over SOI (GCP), as there will be no change in extent. Further, as the points are not transferred, the data is not differentially corrected by User Agency, GIS cell processed data is taken into consideration, ignoring the coordinates submitted by User Agency. As such, the DGPS data is only verified, and the absolute location of points shall be verified by the concerned field officers only. However, the revised ETS & DGPS/GNSS Survey data received through reference 4<sup>th</sup> cited has been **accepted at this stage**.

The proxy RF boundaries depicted on topomaps are used for ascertaining the entry & exit points of alignment with RF. The division boundaries are ascertained with the help of available records. The details of extent of area are as follows:
