Brief Summary of the Project Road

Name of Project: 4 Laning with Paved Shoulder from Naviganj to Mitrasen Section

(Km. 289+000 to 356+000) of NH - 91 (Aligarh - Kanpur) in Kannauj District.

- Project Road: National Highway 91 is a main highway in the state of Uttar Pradesh in upstate India with a length of 405 kilometres. It begins in Ghaziabad on NH 58 and via Aligarh to Kanpur to NH-2. The Feasibility report are to be prepared for the Aligarh to Kanpur section of NH-91 start from km. 140+200 at Aligarh and ends at km. 414+000 in Kanpur Town. The Existing Alignment passing through Aligarh, Hathras, Etah, Mainpuri, Kannauj and Kanpur Nagar districts of Uttar Pradesh.
- As per the 31st Meeting of the PPPAC held on February 2010, the project road NH-91 was proposed to be widened to 2 lane with paved shoulder configuration, though the project had traffic of over 14,000 PCUs. For level of service B, such traffic met a four lane highway.
- The forest proposal had submitted for the five districts for diversion of forest land, as per following details:

- The project road was deferred to be upgraded as 2-lane paved shoulder due to some technical reasons, by this time project has been qualified for the 4-lane configuration. Accordingly government decided this project to be implemented in a 4-lane divided carriageway as per the MoRTH guidelines for 4/6 lane manual in the year 2014 & 2015.
- As per the administrative approval received in 5 Packages under the section of NH-91(start from km. 140+200 at Aligarh of Pkg. 1st and ends of 5th Package at km. 414 in Kanpur Town) letter no. RW/NH-37011/43/2012-PPP, dated 1st March 2018& RW/NH-37011/04/2018-PPP dated 26 march 20189. The details of 5 Packages as given below.
