Vide reference 2nd cited, MOEF has accorded Stage-II/Final approval for diversion of 258.028 Ha of forest land in the RF of Karimnagar East Forest Division for laying of pipe lines/ Construction of 08 Tanks/ canals & distributaries under Kaleshwaram Project Lift Irrigation Scheme.

The Chief Engineer & Regional Officer, MORTH, Hyderabad vide reference 10th cited has requested the consent/No Objection Certificate for rediverting the 5.1808 Ha (8.63482 Km length x 6.0 M Width) of forest land (out of 258.028 Ha of acquired forest land) for forming the shoulders of National Highway in the diverted (acquired) forest land of KLIS meant for inspection path, stating that, the paved shoulders will also serve as inspection path/road for the Lift Irrigation Scheme of I &CAD Dept i.e., primary user agency and the same was recommended by the Executive Engineer, SYP Division No.1, Ramagundam vide reference 11th cited. Subsequently, the Engineer-in-Chief, Kaleshwaram Project, LMD Colony, Karimnagar has permitted to give consent in the above subject matter as proposed and recommended by the Executive Engineer, Sripada Yellampally Project Division No.1, Ramagundam vide reference 12th cited.



Further, the above proposed new use/activity by the Chief Engineer & Regional Officer MORTH, Hyderabad i.e., Secondary user agency in the diverted forest land of I & CAD Department i.e., Primary user agency is compatible and does not hinder its use for which the forest land already stands diverted.



As such, the Superintending Engineer, Kaleshwaram Project Circle No.1, Ramagundam i.e., Primary user agency, has <u>no objection</u> for forming the shoulders by the Chief Engineer & Regional Officer MORTH, Hyderabad i.e., the Secondary user agency, in the acquired forest land of KLIS along the road which also serves as inspection path to Kaleshwaram Lift Irrigation Scheme (KLIS) i.e., Primary user agency, I& CAD Dept., duly adhering to the formulated conditions by the MoEF vide reference 2nd cited. Both the Primary User and the Secondary User shall use this stretch of 6.0 m wide and 8.63482 km length as common road.
