It is requested that preparation / Submission of Site Specific Wildlife Conservation Plan be included in the proposed Stage-I stipulation condition in view of the enclosed site inspection report. The area inside the Donga R.F. proposed for diversion is about 5.476 Ha. This area comprised of endangered flora and fauna species.

There is historically recorded elephant movement in the area. Also presence of pangolin, sloth bear, Leopard, Wild Boar, Sambar, Barking Deer, Elephant Movement etc recorded in this area.

Thus for maintenance of ecological continuity and ecosystem coherence in side the project affected area in Donga R.F. the Site Specific Wildlife Conservation Plan is recommended to be included in the proposed Stipulated condition of Stage-I approval of the project.
