

SUB: Reply to the queries raised in Parivesh Portal with respect to the Stage-I Forestry Clearance Application for diversion of 113.94 Ha Forest Land in favour of Chitra East OCP under SP Mines Area, ECL

REF: FC Proposal No FP/JH/MIN/150657/2021

Dear Sir,

In reference to the above-mentioned Forestry Clearance proposal of diversion of 113.9 Ha Forest Land in favour of Chitra East OCP under SP Mines Area, the reply to the queries raised from your end vide letter no 1285 dated 20.09.2022 are as follows:

1. Detailed Note about the Project showing the affected villages, the beneficiaries from the project, permanent and temporary employment generated from the project is enclosed as **Annexure-I**.
2. The plan of the approved Project Report of Chitra East OCP is enclosed as **Annexure-II**.
3. Detailed KML file of the total project area showing quarry area and OB dumping area is enclosed as **Annexure-III**. As there is no option to upload additional KML files in PARIVESH Portal, the said KML is submitted in a CD along with hardcopies of the files submitted at your good office. However, screenshot of the KML file is being uploaded in PARIVESH Portal as **Annexure-III**.
4. Application for conducting Gram Shabha and providing NOC under Settlement of Rights under Schedule Tribe and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 has already been submitted to Deputy Commissioner, Deoghar (**Annexure-IV A**). As per the guidelines of MoEF&CC issued vide letter no File No. 11-43/2013-FC dated 26.02.2019 (**Annexure-IV B**), the compliance under FRA is not required for consideration of in-principle (Stage-I) approval. However, the process of FRA has been initiated by ECL and will be completed within the stipulated timeline.
5. Joint tree enumeration for the trees situated on the 113.94 Ha Forest Land will be conducted under the supervision of Range Forest Officer, Madhupur Soil Conservation Range, Deoghar Forest

Division. Application for the same has been submitted to the office of Range Forest Officer, Madhupur Soil Conservation Range, Deoghar Forest Division (**Annexure-V A**). An undertaking in this respect is enclosed as **Annexure-V B**.

6. Application for issuance of NOC for the 51.93 Ha GMJJ Land involved in the diversion proposal of 113.94 Ha Forest Land has been submitted to Deputy Commissioner, Deoghar. Out of the 51.93 Ha GMJJ Land, demand of land value for 48.79 Ha GMJJ has been issued by Deputy Commissioner, Deoghar (**Annexure-VI A**) for issuance of NOC and the same has been deposited (**Annexure-VI B**). The issuance of the demand of land value for the balance 3.14 Ha is awaited.

7. The Minimum use of Forest Land Certificate is enclosed as **Annexure- VII**. Justification for locating the project in forest land is already attached in Sl No D of Form-A (Part-1).

8. An application for identification of CA land, twice in extent to the forest land to be diverted i.e. $113.94 \text{ Ha} \times 2 = 227.88 \text{ Ha}$, along with CA Scheme and land suitability certificate has already been submitted to your good office (**Annexure-VIII**). This proposal had been applied on 07.01.2022 before the FC Rules, 2022 dated 28.06.2022 was issued by MOEF&CC, Govt. of India. Accordingly, the provisions of CA on double degraded forest land may please be considered for the instant proposal.

9. A brief summary of the already diverted 124.28 Ha Forest Land in favour of Chitra East OCP under SP Mines Area, ECL is enclosed as **Annexure-IX**.

10. For Diversion of 124.28 Ha forest land for Chitra East OCP a Scheme for Conservation and Preservation of Flora and Fauna had already been approved on 19.03.2019 by PCCF=Cum= Chief Wildlife Warden, Govt. of Jharkhand and relevant amount for implementation of the plan amounting to Rs. 6,78,89,480.00 had already been deposited in CAMPA on 29.03.2019. This plan is for entire Project Area of 780.80 Ha with 10 Km Buffer Zone. However in case additional condition is stipulated by MOEF&CC, the same will be undertaken. An undertaking regarding deposition of requisite fund and compliance of Wildlife Management Plan (if imposed as Forestry Clearance Condition) is enclosed as **Annexure-X**.

The above replies of the queries raised from your end is hereby submitted for further necessary action with respect to the Stage-I Forestry Clearance Application for diversion of 113.94 Ha Forest Land in favour of Chitra East OCP under SP Mines Area, ECL.

Detailed Note on affected villages, beneficiaries and permanent and temporary employment generated at Chitra East OCP under SP Mines Area, ECL

AFFECTED VILLAGES AND BENEFICIARIES:

As per the Project Report of Chitra East OCP, a total of six villages namely Tulsidabor, Khoon, Bhawanipur, Tarabad, Chitra (Part) & Jamua (Part) are to be rehabilitated. The village-wise total number of PAFs to be shifted from above-mentioned villages are as tabulated below:

A comprehensive resettlement and rehabilitation package (social, cultural and economic) will be offered to the project affected families as per the latest Norms of CIL for formulating R&R package. For development of the rehabilitation site with all basic infrastructural facilities like school, road with street light, pucca drain, pond, dug well and/or tube well for drinking water supply, community center, place of worship, dispensary, grazing land for cattle and play ground, a provision of 66.80 Ha of Tenancy Land has been provided in the Project Report. Similar infrastructural facility, if necessary, will be extended to the host locality. The community facilities and services would be available to all residents of the area, including PAFs and the host population.

Benefits provided to the PAFs:

1. Land Compensation
2. Compensation for homestead including Well/ Handpump/ Tree/ Pond/ Crop etc.
3. Alternate housing site measuring 100 sq m or One Time Lumpsum of Rs 3,00,000.00
4. Subsistence Allowance @ 50 Minimum Agricultural Wage per month for 12 months

PERMANENT AND TEMPORARY EMPLOYMENT GENERATED:

Permanent Employment Provision - Apart from payment of the land compensation, employment may be given in the following manner:

1. The maximum total number of employments that may be provided to the land losers would be limited to the total no. of acres of land acquired divided by two. However, employments will be released in proportion to the land possessed.
2. For every two acres of land one employment can be considered;
3. Project may give an option to the Land losers having less than two acres of land to club together their land to the extent of two acres and nominate one of the land losers among the groups or their dependent for employment under package deal or employment under Descending order system by preparing the list of eligible land-oustees in the descending order of land lost subject to the cut off equivalent to the total number of permissible employments or any other method with the approval of ECL Board of the subsidiary.
4. The land loser must be a domiciled resident/Mool Niwasi and the certificate to this effect shall be issued by the concerned State Authority
5. The modalities for offering employment shall be such as may be approved by ECL Board provided that -
 - a) The initial employment shall be given with pay of Category-I pay scale of NCWA, with training period of 6 months.
 - b) In the seniority list, the seniority of the appointee should be reflected in appropriate manner in order to keep the senior most as senior.
 - c) The land loser trainees shall be posted as per requirement, including underground duties.

Lump sum Monetary Compensation:

1. All the land losers who are not eligible for employment as above shall be entitled to receive monetary compensation in lieu of employment at the rate of Rs.5,00,000.00 (Five Lakhs) for each acre of land on pro-rata basis.
2. Land losers who are offered employment as per principle specified in point No (B) above will have the option either to opt for employment or to forego employment and opt for monetary compensation at the rate of Rs.5,00,000.00 (Five lakhs) for each acre of land on pro-rata basis with minimum of Rs. 50,000.00 (Fifty thousand) provided that the employment thus surrendered shall not be available for offer to any other person and will

stand lapsed from the total sanctioned number of employments as specified in point No.(B).

3. The Land losers who have clubbed their land in Package Deal can claim employment for only one land loser of the clubbed two acres of land and remaining land losers of the package cannot claim either employment or lump sum monetary compensation in lieu of the land contributed by them.
4. Annuity: All land losers who are entitled to get lump sum monetary compensation may opt for payment of compensation amount in the form of annuity made payable to the land losers monthly, annually or at such intervals (not less than one year) as may be opted for by him. The annuity is paid for a maximum period extending to 60 years of age or the life of the project for which the land has been acquired, whichever is earlier.


Note: A person receiving a job forgoes all claims to above compensation and a person receiving above compensation forgoes all claims to employment.


Temporary Employment Provision - The Project will assist PAFs to take-up non-farm self-employment through petty contracts or formation of cooperatives. If such co-operatives will not be entitled for awarding work as per Manual for lack of experience, the said co-operative will be facilitated by awarding small jobs to acquire experience after relaxation of the provisions of the Manual pertaining to experience with approval of ECL Boards. Subsequent jobs may be awarded after getting report of the timely completion / quality / of the awarded jobs from the concerned Department or contractors.

Contractors will also be persuaded to give job to eligible PAFs on a preferential basis, where feasible as per terms of contract.

Also, the local population from nearby villages are engaged in coal loading and unloading activities thereby providing them with employment.

Dear Sir,

With due respect, this is to inform you that Chitra East OCP under SP Mines Area, ECL in Deoghar District is a major coal producing open cast project. Out of the total project area of 780.80 Ha, the quantum of forest land that is to be diverted is 238.22 Ha. Out of this 238.22 Ha, already Stage-II Forestry Clearance of 124.28 Ha of Forest Land has been obtained from MoEF&CC. Now, for the expansion of the project, diversion of the balance 113.94 Ha Forest Land is very essential. Mouza-wise details of the said 113.94 Ha Forest Land is enclosed herewith as **Annexure-I**.

For the said diversion of 113.94 Ha Forest Land under FC Act 1980, the application in Form A Part-I for forestry clearance in the Online Parivesh Portal of MoEF&CC is under process. As a pre-requisite for making this application, documentary evidence in support of Settlement of Rights under Schedule Tribe & Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 is required.

In this regard, it is requested that necessary guidelines may be issued to the concerned personnel for organising and conducting a Gram Sabha at a suitable date and provide the certificate, as desired, under the said act in the prescribed format as per MoEF&CC Circular No F.No. 11-9/98-FC (pt.) dated 5th July, 2013 enclosed herewith as **Annexure-II**.







- the discussion and decisions on such proposals had taken place only when there was a quorum of minimum 50 % of the members of Gram Sabha present;
- the diversion of forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the Grama Sabhas have given their consent to it;
- the rights of Primitive Tribal Groups and Pre-Agricultural Communities, where applicable have been specifically safeguarded as per section 3 (1) (e) of the FRA.

Sir,

I am directed to refer to Forest (Conservation) amendment Rules 2016 as amended on 06th March, 2017 wherein inter-alia it has been provided that:

(e) *the District Collector shall*

(i) *complete the process of recognition and vesting of forest rights in accordance with the provisions of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (2 of 2007) for the entire forest land indicated in the proposal.*

(ii) *obtain consent of each Gram Sabha having jurisdiction over the whole or a part of the forest land indicated in the proposal for the diversion of such forest land and compensatory and ameliorative measures, if any, having understood the purposes and details of diversion, wherever required; and*

(iii) *forward his findings in this regard to the Conservator of Forests*

(f) *the entire process referred to in clause (e) shall be completed by the District Collector within the time period stipulated in these rules for grant of in-principle approval under the Act to the proposal.*

(g) *the Conservator of Forests shall examine the factual details and feasibility of the proposal, carry out site inspection in case the area of forest land proposed to be diverted is more than forty hectares, and forward the proposal along with his recommendations to the Nodal Office.*

I am also directed to refer to references/communications received from various State Governments seeking clarification on whether FRA certificate is to be submitted before Stage-II compliance or it has been submitted along-with proposal for seeking Stage-I approval.

It is clarified that within the time period stipulated for compliance of stage-I

condition, Deputy Commissioner shall complete the process of compliance of FRA (including forwarding its findings to the concerned CF). Hence for the purpose of the MoEF&CC, as per the provision under Forest (Conservation) amendment rules, 2016 the compliance under FRA is not required for consideration of in-principle approval. This has to be furnished by the state Govt. for consideration of the proposal by the ministry for final approval.

In view of the above, the State Governments are requested to adhere the provisions contained in Forest (Conservation) Amendment Rules, 2016 for FRA purpose while forwarding the proposal for seeking prior approval under Section 2 of Forest(Conservation) Act,1980 to this Ministry for consideration.
