

# Application Forms

As per Rule 6 of the Forest (Conservation) Rules, 2003, every user agency, who wants to use any forest land for non-forest purpose shall make his proposal in the appropriate form appended to these rules, i.e Form 'A' for proposals seeking first time approval under the Act and Form 'B' for proposals seeking renewal of leases where approval of the Central Government under the Act had already been obtained earlier, to be concerned nodal officer authorized in this behalf by the State Government, along with requisite information and document, complete in all respects, well in advance of taking up any non-forest activity on the forest land.

#### 1. Project details:-

(i) Short narrative of the proposal and project/scheme for which the forest land is required. –

In Gaya District under Barachatti Block the road – L029- T01 to Sisiyatari (BR-12R-991) has been sanctioned under **Pradhan Mantri Gram Sadak Yojana (PMGSY)** during the financial year 2018-19. This is the only Path/Road for the inhabitants of Sisiyatari Village. The length of this road is 13.221 Km and this has been in use prior to 1980. During the passage of time due to incremental growth of population and development, this path/road is reduced in the shape of trail (Pagdandi) which has not been reflected in the village map. But in the Toposheet of forest map it is categorically maintained that there is link road leading towards Tetariya Village under which 13.00 Km viz .....13:20..... Hec seems to be under territorial Jurisdictions of Wild Life Sanctuary/Forest area. Construction of this captioned road is imperative for the welfare of the people and development of this region. It is worthwhile to mention here that during the work of Premix Carpeting of road not a single tree will fall and no harm will be caused to the Wild Life. Except for the width of the road no extra forest land will be utilized for the construction of this road.
