

NOTIFICATION.

His Excellency the Governor in Council is pleased to notify, under the provisions of section 4 of the Madras Forest Act (V of 1882) that it is proposed to constitute the area, the boundaries of which are described in the schedule given below "reserved forest" under the provisions of the said Act.

Surabhu.	<i>North.</i>—Starting from the south-west corner of khandam No. 2 of Surabhu, the south and east limits of that khandam, south limits of khandams Nos. 4 and 5, the south limits of khandams Nos. 17 and 14 to the most southerly point of survey No. 1266 (inside reserve); then the south, west and north sides of that number and north and east sides of survey No. 1264 (inside reserve) to the south-west corner of survey No. 1259; then the south limit of khandam No. 13 to the south-east corner of survey No. 1246; then a straight line to the south corner of survey No. 1249; then a straight line to the most easterly point of survey No. 1250; then a straight line to the south-east corner of survey No. 1240; then the east and north sides of that number to the south-east corner of survey No. 1239; then a straight line to the most easterly point of survey No. 1233; then the east side of survey No. 1233 (all of Surabhu to the south margin of the Rayachoti taluk boundary); then along the south margin of that road to the Rayachoti taluk boundary. <i>East.</i>—The Rayachoti taluk boundary to the south-east corner of survey No. 1605 of Surabhu. <i>South.</i>—The north, west and south limits of khandam No. 19 of Surabhu to the south-east corner of survey No. 1566 of the same village; then the Rayachoti taluk boundary to the village boundary stone east of the south-east corner of survey No. 202 of Gotlimitta. <i>West.</i>—Thence a straight line to the south-east corner of survey No. 211; then the east side of that number to its north-east corner; then a straight line to the north-east corner of survey No. 305; then a straight line to the village boundary stone due north of north-east corner of survey No. 302 (all of Gotlimitta); then the north boundary of Gotlimitta village and the east boundary of Nerusapalle village to the starting point.

2. His Excellency the Governor in Council is further pleased, under the provisions of section 4 (c) of the said Act, to appoint M.R.Ry. K. Gampayya Garu to be the Forest Settlement-officer, who shall inquire into and determine the existence, nature and extent of any rights claimed by, or alleged to exist in favour of, any person, on or over land comprised within such limits, or to any forest produce of such land, and deal with the same as provided in Chapter II of the said Act, and the District Forest-officer, Cuddapah, for time being to attend on behalf of Government during the enquiry.

3. His Excellency the Governor in Council is further pleased, under the authority vested in him by section 14 of the said Act, to appoint the Collector of Cuddapah for the time being, to be the officer of the Revenue Department, who shall hear appeals from orders of the Settlement-officer passed under sections 11, 12 and 13 of the said Act.
