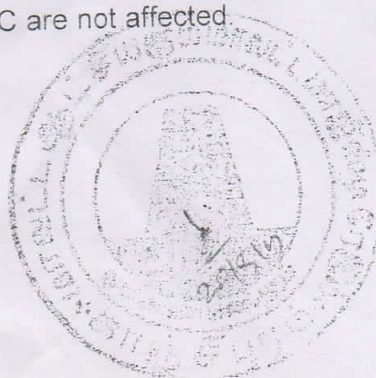

In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No.11-9/98-FC(pt) dated 3<sup>rd</sup> August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA' for short) on the forest land proposed to be diverted for non-forest purposes, to be diverted non forest purposes read with MoEF's letter dated 5<sup>th</sup> February 2013 where in MoEF issued certain relaxation in respect of linear projects, it is certified that 0.288 ha of forest land, proposed to be diverted in favour of User Agency / Project proponent Thiru. - b) The proposal has been examined with reference to the ensuring compliance of scheduled Tribes and other traditional Forest Dweller (Recognition of Forest Rights) Act 2006.
- c) There are no Scheduled Tribes and other Traditional forest Dwellers in the forest areas of the Paratur village Thirutheri Reserve Forest of Chengalpattu taluk, Kanchipuram district and consequently no claim have been received under this Act with respect to the area proposed.
- d) There are no tribal Groups (PTG) and Pre-Agricultural Communities (PAC) in the forest area of Thirutheri village of Chengalpattu taluk, Kanchipuram District, Hence the recognized rights of PTG and PAC are not affected.
