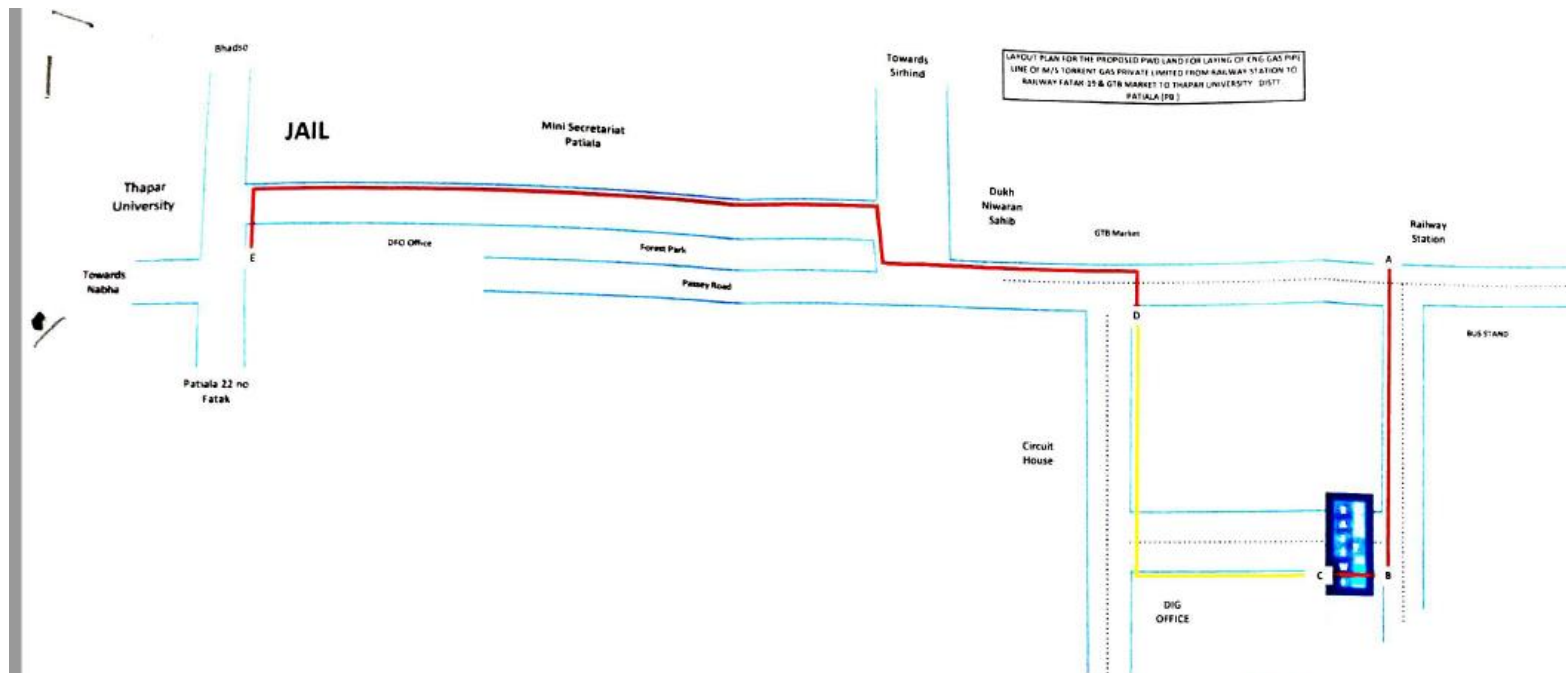

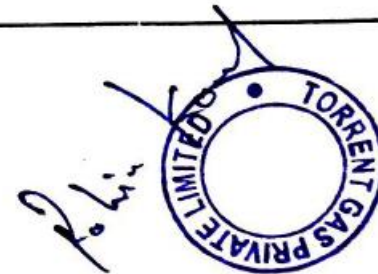

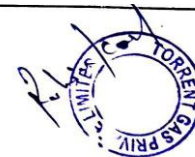

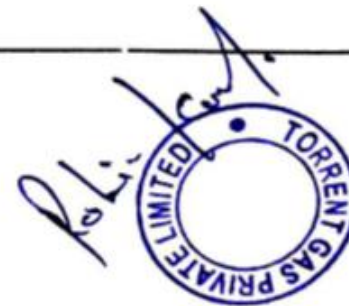

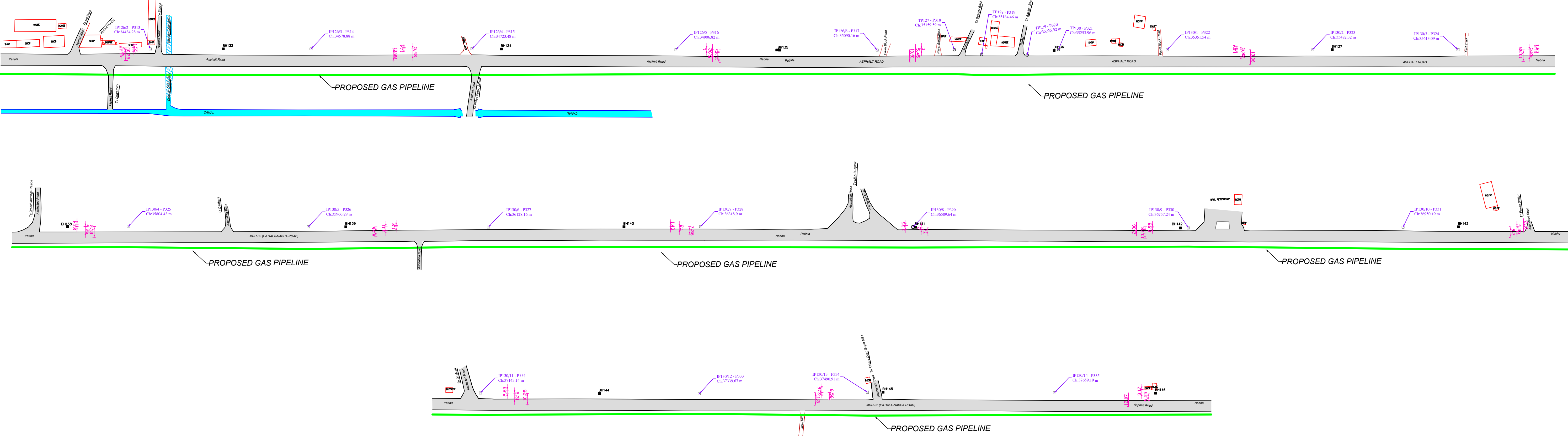
12" PROPOSED GAS PIPELINE ROUTE MAP



12" PROPOSED GAS PIPELINE ROUTE MAP

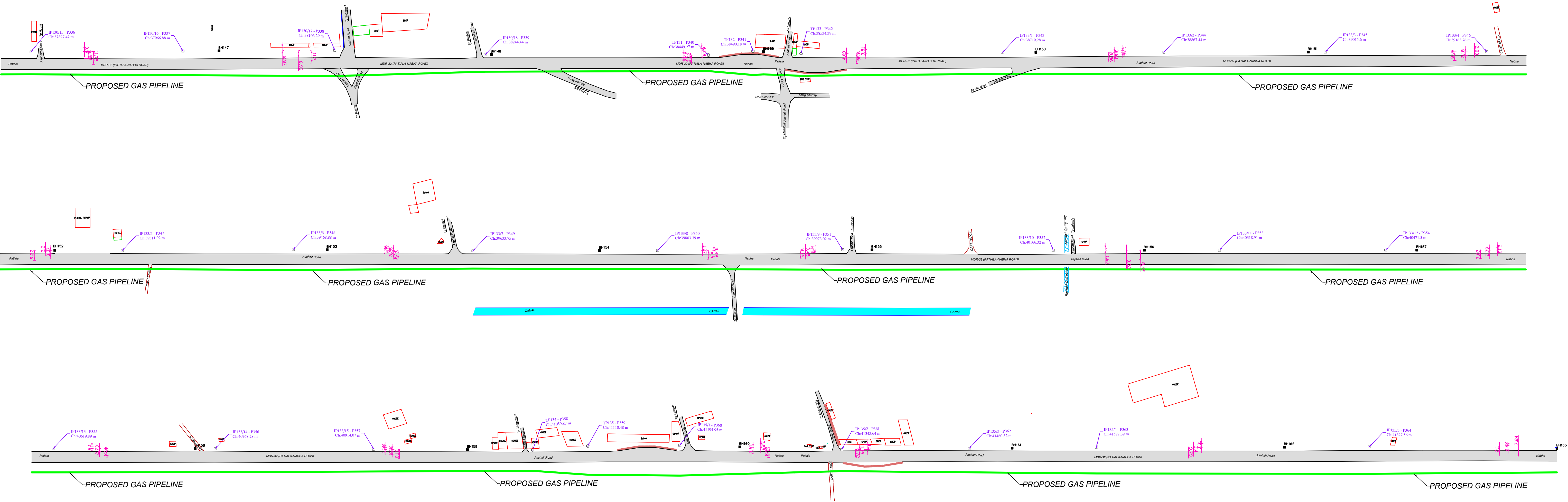
