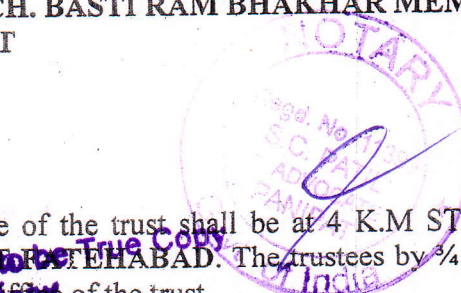

3. Purpose

I. That the trust has been created for charitable purpose and object of the trust includes following objects:-

- a. To develop need based Academic and Vocational Education Programmes for livelihood and lifelong learning up to pre- degree level.
- b. To Construct and run School , College, universities and Library for use of general Public
- c. To providing relevant, continuing and holistic education up to pre-degree level through Regular/ Open and Distance Learning System and online education and examination.
- d. To attain excellence in developing quality Open and Distance Learning curricula and courseware for learners.
- e. To accredit institutions for developing effective learner support system to facilitate learning up to pre-degree level.
- f. To strengthen the Open and Distance Learning system through Research and Development activities.
- g. To promote open schooling at national and global level by networking, capacity building, sharing of resources and quality assurance.
- h. To Construction, repair and maintain Dharamshala for use of General Public.
- i. To provide professional advice to the Government of India, and to the States, regarding proper development of Open and Distance Learning system at school level in response to requests from the concerned Government/s or suo moto.
- j. To grant financial help ,scholarships, stipend and other aid to the needy and Deserving students.
- k. To grant relief by way of giving Donation, Contribution, Subscription, Monetary or financial assistance or aid to the dumb, deaf, blind, orphan old people, widow, poor or needy person or any organization or institution established in respect thereof.

II. To Construct Trust for the use of general public and to do all such Acts, as are ancillary and connected with or related to the efficient running and management of Trust.

And to determine their powers and to require securities in such instance and such instance and such amounts as the trustees may think fit. The trustees shall also have powers to fix and maintain provident fund, gratuity funds, personal or other funds for any employees and make rules and regulations regarding the same.

- iv) The trustees shall have power in general to acquire all things and do all acts necessary to carry out the objectives of the trust.
- v) The trustees shall have power to deposit the trust money or any portion thereof in any scheduled bank or banks by way of fixed deposits or in current accounts or jointly by two trustees one of them shall be managing trustee or chairman of the trust.
- vi) The trustees shall have the power to invest the trust money in any government securities or in any other approved manner & also to invest in such manner as may be directed by the board of trust.
- vii) For the purpose of carrying out of the objects of the trust, the trustees shall have the power to acquire by purchase or on lease or otherwise any immovable property of any nature or do any act for the attachment of the main objects.
- viii) It shall be lawful for the trustees to pull down, renovate, rebuild, alter, adopt, improve any movable or immovable property comprised in the trust properties and to spend thereon such amount out of the trust fund or the income thereof as they may think fit.
- ix) The trustees shall be entitled to enter into any agreement or covenants with the owner of or person entitled to or interested in any other properties and to raise funds by way of loans from Banks, Financial Institutions & Other
- x) It shall be lawful for the trustees at such time or times as many in their absolute discretion think fit to sell by public auction or private contractor exchange or transfer or assign, grant, lease or sublease for any term, however long or otherwise dispose of all or any part of the trust properties including immovable properties.

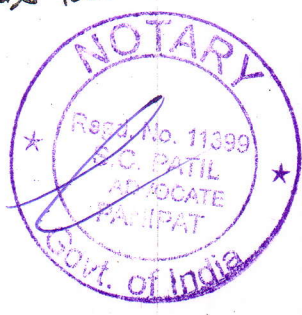

11 Voting power of the Trustees

In case of difference of opinion arising amongst the trustees and in all matters wherein the trustees shall have a discretionary power, the opinion of the majority of the trustees present and voting shall prevail and be binding on the majority as well as on these trustees who may not have voted and if the trustees shall be equally divided in opinion the matter shall be decided according to the casting vote of the chairman.

13. Meeting of the Board of Trustees

The meeting of the Board of Trustees shall be held at least once in a year but any number of other meetings may be held as and when considered necessary.

14. Maintenance of Minute Book

A minute book shall be kept by the trustees. Proceedings of the meetings of the board of trustees shall be entered in the minute book and shall be sign by the chairman of the meeting either at the conclusion thereof or the next meeting or when they shall have been fully completed.

15. Maintenance of Books of Accounts

Proper and regular books of accounts of all amounts of all receipts and expenditure of the trust shall be maintained by the trustee either in the Hindi language and script or in English or partly in Hindi or partly in English or script.

16. Accounting Period

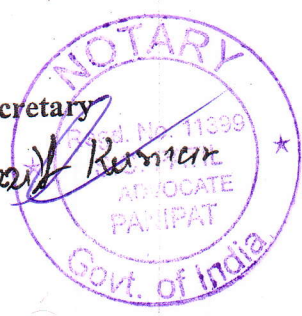
On the 31st day of March every year a general account shall be taken of all the assets and liabilities of the trust and an income and expenditure account for the whole year and a balance sheet as on 31st March shall be prepared and shall be passed by the trustees. The account of the trust shall be audited annually by a Chartered Accountant appointed by the trustees for the purpose.
