#### DETAIL NOTE ON THE PROJECT

The forest land is required for the construction of motorable link road to From Ghatti Ghar (Pukhri) to village Saluin KM 0/0 to 3/338 in District Chamba, Himachal Pradesh is being constructed by HP.PWD. Division Tissa (H.P). The total length of road 3.338 Kms. out of which 2.535 Km. would pass through the forest land and the rest 0.803 Km. is proposed to be constructed in the non-forest land.

The total land involved in the construction of this road is 2.3628 hectares ( 1.5210 hect. for road construction and 0.3600 hect. for dumping site for disposal of muck) and the rest 0.4818 hectares is non-forest land. The 4 No. dumping sites have been proposed and the area of 0.3600 hectare is required for dumping site for disposal of muck.

With the construction of this road village Saluin and its surrounding sub village will be improved considerably. These villages falls in the BASP belt of Chamba District and villagers are very poor. The horticulture and agriculture produce such as Peaches, Walnuts, Potatoes and Pulses are grown in the area and people face lot of problems in marketing the above crops for want of the road. The other services like health, education and other development activities will be improved with the construction of this road. The people shall gain employment on the construction activities and activity shall help in ameliorating the poor economy of the area.

#### Cost of Project & Employment Generated :

The total estimated cost of project is to the tune of Rs. 240.35 lacs and approximately 7530 maydays of employment would be generated with the construction of this road.

#### Environment details :

The ill effect environment, which are anticipated with the construction of this road have been taken care of. The actual quantity of muck is 54501.15 Cubic Metre. By taking a swell factor of 40% on pick and jumper work and 25% on blast work the total muck becomes 113936.29 cubic metre out of

which 68361.78 cubic metre muck/excavated is to be used locally for dry masonry and leveling of proposed road. After giving allowances for local consumptions the muck to be disposed off is 45574.52 cubic metre. The area of dumping place 3600.18 Square metre which has capacity for dumping of muck 45799.00 Cubic Metre. The proper provision has been made to minimize the soil erosion in the catchment by proper drainage and soil conservation measures. The compensatory afforestation shall also be carried out to compensate for the loss of forest land in the construction of road. Thus every care has been taken to minimize the ill effects on the environment.

#### Plantation method :-

Nursery grown one year old plants (in polythene bags as well as naked root) will be planted in 30x30x30cm. and 45x45x45 cm. pits in the selected area. Bush cutting will be done in the infested area. The plantation will be maintained for subsequent 10 (Ten) years in which beating up of failures will be done. The plantation will be rainfed.

#### Protection (Fencing, Watch man, People's Participation etc.) :-

Area will be protected from grazing by erecting barbed wire fencing at all vulnerable places around the plantation. Further watch and ward as also fire protection will be ensured through regular departmental staff.




Hence the spacing will be kept at 1.5 mtr. x 1.5 mtr. The total area involved in dumping is 3600.18 Square metre. Also due to inert nature of soil, plants will need extra care for their establishment. For this purpose, imported soil/ organic manure will be added in each pit for easy establishment of plants. Watering of the plant in dry season will be provided to prevent mortality. The plantation will be further maintained at project cost for next ten year beating up of failure will be done.

Post reclamation arrangement :

Since the area in question is required by the user agency only for the temporary use of dumping, hence the area will be reverted back to forest department after implementing the reclamation plan, if so stipulated by Govt. of India. However if at the time of so reverting back the areas to forest department if any activities as per this reclamation plan is found wanting then the forest department may realize the cost that activity from the user agency at the prevailing wages rates applicable in forest department and may get the same done departmentally at the project cost.


