 10 (hereinafter called Contractor) WE ICICI Bank Ltd, a schedule bank in India incorporated under the
 11 Provisions of the Companies Act, 1956 and having its registered office at Landmark, Race Course
 12 Circle, Vadodara - 390 007 and having a branch office at ICICI Bank Ltd, 4A Ground Floor, Reliance
 13 Corporate Park (Nocil) Near Ghansoli Rly Station, Thane Belapur Road, Navi Mumbai 400 701
 14 hereby undertake to pay the principal an amount not exceeding Rs.720000/- (Rs. Seven lac twenty
 15 thousand only) against any loss or damage caused to or suffered or would be suffered by the
 16 principal, by reasons of any breach of the terms or conditions contained in the said agreement.

17 2. We, ICICI Bank Ltd do hereby undertake to pay the amount due and payable under this
 18 guarantee without any demur, merely on a demand from the principal stating that amount claimed
 19 is on account of making good and executed trench for laying of underground cable of proper
 20 filling and compaction, as to restore the land in the same condition as it was before digging the
 21 trench, debris/loose earth produced due to execution of trenching. However our liability under this
 22 guarantee shall be restricted to Rs.720000/- (Rs. Seven lac twenty thousand only) We undertake to
 23 pay the principal any money so demanded notwithstanding any dispute or disputes raised by the
 24 contractor(s) in any suit or proceeding pending before any court or tribunal relating there our
 25 liability under this present being absolute and unequivocal. The payment so made by us under
 26 this bond shall be a valid discharge of our liability for payment there under and the contractor(s)
 27 shall have to claim against us for making such payments.

28 3. We, ICICI Bank Ltd further agree that the guarantee herein contained shall remain in full force
 29 and effect during the period would be taken for the performance of said agreement and that it
 30 shall be continued to be enforceable till all the dues of the principal or by virtue of the said
 31 agreement have been fully paid and its claims satisfied or discharged or till the principal certify
 32 that the terms and conditions of the said agreement have been fully and properly carried out by
 33 said contractor and accordingly discharges this guarantee or till 02.05.2017, whichever is earlier,
 34 we shall be discharged from our liabilities under this guarantee thereafter.

35 4. The guarantee will not be discharged due to the change in the constitution of the bank or of the
 36 contractor.

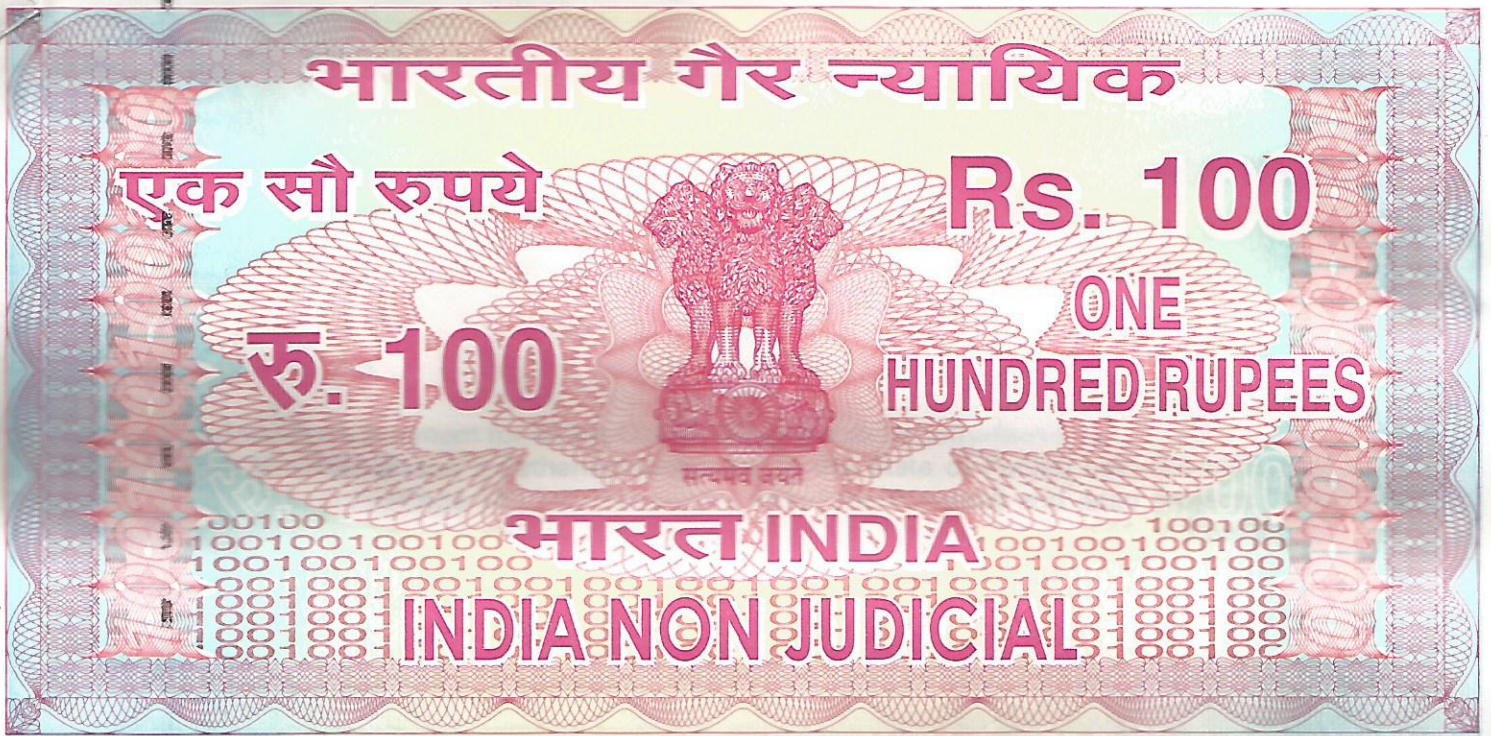
