Dear Sir,

With reference to the above cited subject and letter the point wise reply to the raised shortcomings are as follows:

**Point No.1: PF Notification of NFL provided for CA against the earlier diverted area has not been submitted in compliance to observation No.iii of PCCF (FD & NO, FC Act).**

Balram OCP has already submitted an undertaking that 86.00 HA CA land identified against the diversion of 85.201 Ha forest in the Harpalli village in Kuarmunda Tahsil, Rourkela division will be notified as protected forest following due procedure before grant of Stage-II FC(Re-submitted under **Annexure-I**).

The CA Land has been mutated in favor of forest Department. The ROR copy of the same has already been submitted as Annexure-II in our reply vide Ref No:MCL/GM/HA/Envr./2023-24/422 Dated 08.02.2024. This is resubmitted and attached as **Annexure-II**.

For this purpose, DFO Rourkela was requested vide Letter no. MCL/GM/HA/Envr/2023-24/410 dated 01.12.2023, to provide the details of the CA carried out in the identified 85.201 Ha non forest land in Harapalli village, Sundargarh district, in respect of the previous 85.201 Ha FC approval of Balram Opencast Project 8.0 MTY (Earlier known as Kalinga OCP) and a copy of the notification of the said land as protected forest as per the condition no. (ii) of approval letter dated 28.09.1990.

However, the CA land is yet to be notified as protected forest and for this purpose, DFO Rourkela requested to cause a DGPS survey of the CA land at Harapali Village of Panposh Tahasil at Kuarmunda and authenticate the same from ORSAC, Bhubaneswar. (Memo no. 11449/4F- Dt: 06.12.2023) (**Annexure III**). The DGPS survey was completed by the team from ORSAC from 19.04.2024 to 25.04.2024 in presence of officials from Balram OCP (Hingula Area, MCL), Forest department (Kuarmunda Range) and Revenue department (Tahasil Panposh at Kuarmunda). The DGPS Map for the CA Land is being prepared by ORSAC Bhubaneswar. As soon as it is recieved, it will be submitted to the DFO Rourkela for further necessary action for the notification of the said CA Land as Protected Forest.

**Point No.2:** The reasons for non-payment of NPV for the entire forest area within ML has not been furnished in compliance to observation No. v of the PCCF( FD & NO,FC Act).

The demand for the payment of NPV for the 193.845 Ha forest land (proposal under progress for stage – I) has been raised by the your good office on 04.05.2024. The amount has been approved at our end (copy of approved notesheet enclosed as **Annexure IV**) but we are unable to upload the demand raised after which the challan can be generated for the payment of NPV.

Generally the NPV payment is paid after the grant of Stage – I (as compliance of Stage – I). But as the stage – I FC has not been granted we are unable to upload the demand on the parivesh portal. A complaint for the same was raised vide no. TIC-24008814 on dtd.10.05.2024 (Screenshot attached as **Annexure V**). Further, a reply was received from the NIC team on the portal on 13.05.2024 (screenshot attached as **Annexure VI**), which states:

**“As per discussion in any case, there is no option to make payment in Parivesh portal before stage-I is granted to the FC proposal through the online process”**

Therefore, as there is no option to make payment in the Parivesh portal, as of now, Balram OCP is unable complete the payment for the NPV for the 193.845 Ha forest land (proposal under progress for stage – I) as per the demand raised by your good office on 04.05.2024. However, as soon as the option to make the payment opens, the payment will be completed.

In view of the above, it is requested to kindly consider above pointwise compliance for further processing of the proposal.





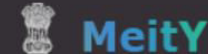
