

**MINUTES OF THE MEETING OF DISTRICT LEVEL COMMITTEE
UNDER SCHEDULED TRIBES AND OTHER TRADITIONAL FOREST
DWELLERS (RECOGNITION OF RIGHTS) ACT 2006**

Proposal has been submitted by the Vennanthur Block Development Officer through online to the Principal Chief Conservator of Forests, Chennai for the formation of link roads to the hamlets at Namakkal District, Rasipuram Taluk, Vennanthur Block **Pudupatti to Kedamalai Road** through the RF to an extent of 2.71.0 ha and **Vadugam to Melur** to an extent of 5.96.0 ha under the scheme "*Prathan Mantri Gram Sadak Yojana*". The proposal has been scrutinised by the Principal Chief Conservator of Forests, Chennai and requested to rectify the defects pointed out. Out of that rectifications one of the rectification is the complete procedure to be followed under the Forest Right Act 2006 for the formation of road and requested to enclose the certificate of collector for the settlement of Forest Rights.


Under the Chairmanship of District Collector meeting was conducted at Namakkal District Collector Office on 03.01.2018 at 4.30 pm in order to get the recommendation of District Level Committee under Forest Right Act 2006 for the formation of above mentioned roads.

District Forest Officer, Adi Dravidar and Tribal Welfare Officer and the Kollihills Tribals Community Members namely Tmt.P.Thamaraiselvi and Thiru.C. Rajendhiran were participated in the meeting.

Under the road formation Scheme from Pudupatti to Kedamalai of Rasipuram Taluk, Namakkal District the proposed road lies in R.Pudupatty Village, SF.No.456 and it starts from Malai Poramboke Land to Kedamalai Road. The proposed road lies in SF.No.89 of Pudupatty RF consists a total extent of 2891.97.0 ha Proposed length of road to an extent of 2.71.0 ha having a average Width of 4.50 m to 8.00 m and a length of 4.70 km.


Another proposed road from Vadugam to Melur which lies in SF.No.101 and it starts from Malai Poramboke Land via Keelur Village to Melur Village. This road lies in SF.No.188 of Mallur RF Consists total extent of 2375.70.0 ha Proposed length of road to an extent of 5.96.0 ha having a average Width of 4.50 m to 6.00 m and a length of 13.05 km. Under Forest Right Act, no right was claimed in the Reserve Forest areas in the Forest Right Act meeting held on 13.12.2005 by the Revenue Department. For the formation of Block Topping road from Pudupatti to Kedamalai and Vadugam to Melur, resolutions have been passed by the Keelur Village panchayat Grama Sabha meeting held on 14.07.2017. Based on the resolution passed by the Grama Sabha the Divisional Level Committee has given approval for the formation of above mentioned roads. For the recommendation of District Level Committee, meeting held on 03.01.2018, as

there is no Forest Right was claimed and no objection on the formation of above mentioned roads it was unanimously agreed by the all committee members and decided to give approval for the above mentioned roads, then the meeting come to an end.
