

i)	Short narrative of the Proposal and Project / Scheme for which the forest land is required	<p>The Kedamalai village at Keelur panchayat of Rasipuram Taluk in Namakkal district is located at Pudupatty Reserved forest area. There are 502 nos of Tribal people living at this village. It has no connectivity between the adjacent Villages, market centre, Hospitals, Schools and Colleges. At present peoples are using the footpath along the reserved forest area for their needs. <b>This village comes under Unconnected Habitation as per the PMGSY Corenetwork.</b> Hence it is proposed to construct the road from Pudupatty to Kedamalai Km 0/0 to 11/375 through Pudupatty Reserved forest by diverting 2.71 Ha. Of forest land for this village for permanent relief to the public Under PMGSY PHASE X.</p>

iv)	Justification for locating the project in the forest area.	<p>The Kedamalai village at Keelur panchayat of Rasipuram Taluk in Namakkal district is located at Bodhamalai Reserved forest area. There are 502 numbers (census 2001) of Tribals living in this village. It has no connectivity to the adjacent Villages, market centre, Hospitals, Schools and Colleges. At present people are using footpath along the reserved forest area for their needs. This village comes under Unconnected Habitation as per the PMGSY Core network. Students, Farmers, labours and patients are highly affected due to non availability of connectivity. At present the Agricultural goods like paddy, sago arid others are transported by means of head load to market due to poor connectivity. So the economic status of this village is suffering continuously. The project will help to improving the standard of living as well as the agricultural well being. School students will be able to access schools without difficulty and the sick, invalid people will face the difficulty in accessing the health care facilities.</p> <p>This project/ road will be important arterial node for the people of Keelur in merging themselves with the</p>
