	(iv) Justification for locating the project in forest area	As per policy of Govt. of India every Panchayat Headquarter is to be connected with roads. Public works department has prepared a core network in the state of HP. Core network has been prepared by Distt. wise, block wise in the state as such a DPR has been got approved from competent authority for CONSTRUCTION OF GANI TO BHORANI NALA ROAD KM.0/00 TO 7/200 . Panchayat Connectivity and PHQ Lot in Chachyot Block of Mandi District. Chachyot Block is amongst one of the most interior block in the State. PHQ Lot is surrounded by demarcated forests. As such forest case diversion of 4.6147 Hect. Forest land including dumping site for the construction of a road from CONSTRUCTION OF GANI TO BHORANI NALA ROAD KM.0/00 TO 7/200 has been prepared for sanction from competent authority. All possible measures have been taken to involve the minimum possible forest area. Alternative alignment were explored and this one taken as final for preparation of DPR & Forest case.
	(v) cost-benefit analysis	Not required as the area of diversion of forest land is less than 5 hac.
	(vi) Employment likely to be generated	However the construction of the road will be done by "A" Class contractor by using mechanical equipment, yet employment of local people will be given as per policy of HP Govt. as such by taking 30% of the total cost 1,73,05,800 lacs for employment generation will be 16,224 mandays.. More important is that by construction of this road the people of this area will self employment by growing cash crops like fruits & vegetables which will boost up their economy.
2	2. Purpose-wise break up of the total land required:	3.9675 hect. Forest land is required for construction of a road from CONSTRUCTION OF GANI TO BHORANI NALA ROAD KM.0/00 TO 7/200 . whereas 0.6472 hect. forest land will be required for dumping of the muck extracted by formation cutting of the road in forest land. As such total 3.9675 hect. land is required for construction of a road from CONSTRUCTION OF GANI TO BHORANI NALA ROAD KM.0/00 TO 7/200 . including 0.1221 hect. of Private Land.


Work Charged Staff:
