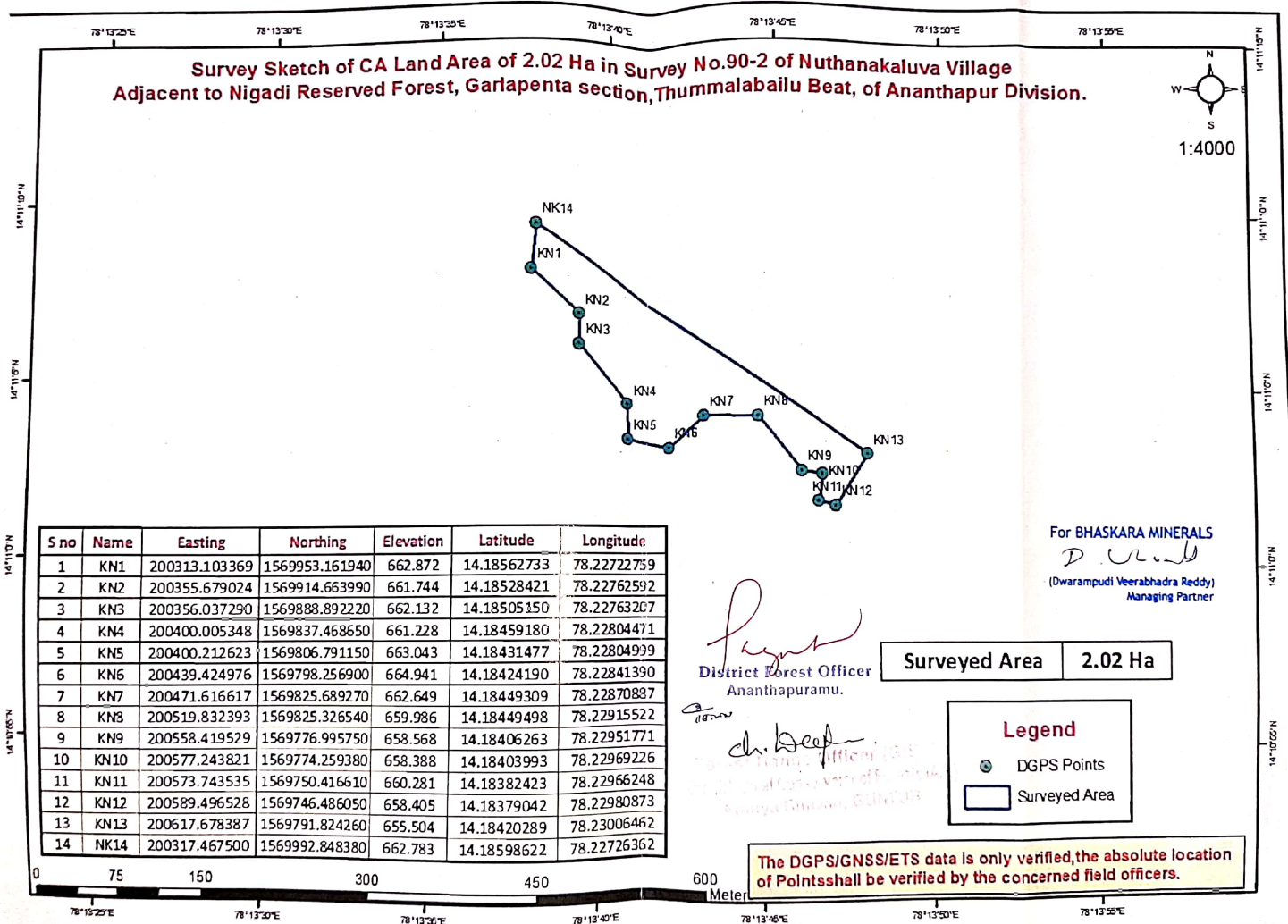
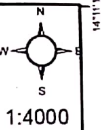


**Survey Sketch of CA Land Area of 2.02 Ha in Survey No.90-2 of Nuthanakaluva Village
